# Domestic Letter Services

In accordance with the service, the pricing of letters is based on the quantity, weight, size, recipient delivery area and processability of items as well as on the preparatory work done by the sender. The price also depends on the additional services used and the items' batch sizes.

## Priority and Economy letters

# Sending valuable items in Finland

The pricing of valuable items is based on the weight of the items and, for an Insured Item, on the value of the item. The total price also depends on the additional services used.

Both the sender and the recipient can immediately track a valuable item using the tracking code received from the ordering channel. The notice of arrival will be sent to the recipient as an SMS or to the recipient's OmaPosti app or email address if the recipient's mobile phone number and email address have been recorded on the item.

Registered Letters, Letters with Advice of Delivery and Insured Items are only handed over to an identified recipient against a signature.
