## Maxi Size

- Minimum size: any of the width, length or thickness dimensions exceeds the size 250 x 353 x 30 mm
- Maximum size: length + width + thickness 900 mm, at the most; length, however, 600 mm at the most.
- Maximum size in roll form: length + twice the diameter 1,040 mm at the most; length, however, 900 mm at the most.
- Maximum weight 2 000 g.
