A Message from the CEO

The United Nations declared 2010 as the International Year of Biodiversity to shed light on the vital role that biodiversity plays in sustaining life on earth. Biodiversity, which encompasses all living things including plants, animals and the ecosystems they inhabit, is seriously threatened by a growing global population, urban development and significant loss of forest cover.

A crucial step in conserving biodiversity is protecting our forests and trees. By protecting and increasing the amount of forested land, we can ensure that our ecosystems become resilient enough to mitigate the effects of climate change.

Forest ecosystems play a crucial role in offsetting the carbon in our atmosphere and reducing greenhouse gas concentrations. We rely heavily on trees to purify our air and provide us with the fresh oxygen we need to sustain life on this planet. We depend on trees to clean our fresh water resources by filtering our rain water and protecting against soil erosion. We count on trees to moisten our air, to give us shelter from the wind and to protect us from the sun.

A mounting volume of research over the past 30 years indicates that the health of our forests has a direct impact on our own personal health. The health of our environment can and will affect us all.

Billions of dollars are spent annually on health care services to treat illness symptoms rather than addressing the root cause of many commonly occurring diseases. Strong evidence suggests that the health and integrity of our forests affect our own health and well-being. It is crucial that we invest in rebalancing our ecosystems and increasing forest cover levels.

To enhance the health of our environment and our personal health, Trees Ontario is re-building the infrastructure and capacity to increase forest cover levels and to ensure that our environment has the resiliency to adapt to an ever-changing climate.

We continue to witness a growing interest and awareness across all sectors regarding the importance of maintaining and enhancing our natural environment. If we, as a population, intend to enhance the health of our environment now and for future generations, we must continue to build the infrastructure required to implement the on-the-ground activities. We no longer have the luxury of being passive bystanders.

We must take a proactive approach to adaptive management, assisted migration and enhanced monitoring to properly assess our efforts and successes.

We are thrilled to announce that this year we supported the planting of more than 2 million trees and reached a significant milestone—10 million trees planted since 2004 with more than 65 partners and 2,000 landowners. We continue focusing our efforts to restore and sustain forest cover by increasing the capacity and competency of local community-based tree planting organizations. Our goal is to increase this capacity to support the planting of 10 million trees a year by 2015.

We are extremely pleased with our accomplishments this past year and recognize that they are as a result of the excellent support of landowners, planting partners, nurseries, government, corporate sponsors and individual donors.

We all have a responsibility to protect and conserve global biodiversity which is essential for healthy and resilient ecosystems. Without a healthy ecosystem we can't sustain a healthy planet and we will surely compromise the health of our children and future generations. Trees Ontario is the largest not-for-profit tree planting partnership in North America. Our overall goal is to restore the province's tree planting capacity on predominately rural landscapes by providing financial incentives to landowners and support to its tree planting partners.

Trees Ontario is leading efforts to re-green the province through a tree planting network consisting of ConservationAuthorities, Ontario Stewardship Councils, forestry consultants, First Nation communities, municipal governments and community volunteer groups.

Over the years, Trees Ontario has focused efforts to enhance the capacityand competency of its local partners and has witnessed a continuous increase in tree planting levels.

This year, we reached a milestone—10 million trees planted since 2004 with approximately 2.000 landowners.

Trees Ontario's goal is to support the planting of 10 million trees a year by 2015.






Trees Ontario Tree Planting Programs

| 50 Million Tree Program | As part of the Ontario government's 50 Million Tree Program, the Ministry of Natural Resources (MNR) has partnered with Trees Ontario to plant trees on rural lands across southern Ontario. The program is designed to significantly reduce landowner's costs of large-scale tree planting and thereby increase the number of trees planted. | 2,047,482 trees |
| Trees Ontario Forest Restoration Program | Trees Ontario's Forest Restoration Program provides planting agencies with subsidies to help reduce the landowner's planting costs. In turn, the planting agency provides landowners with all services required to plant the trees, including site inspection, preparation of site plan, ordering stock, site preparation, overseeing the tree planting, tending and follow-up survival assessments. | 147,085 trees |
| Special Projects | Trees Ontario supports select special projects, which are dealt with on a case-by-case basis. Planting agency partners are asked to submit a project proposal, which is then reviewed by a technical advisory committee. | 33,585 trees |

Educational Programs

Technical Workshops

To expand Trees Ontario's partnership network and to enhance the expertise of current planting delivery agents, 4 technical workshops were organized and delivered to more than 100 forestry professionals:

- 2 Site Plan Development Courses—Fall 2010
- 2 Tree Plant Primer Workshops—Spring 2011

To respond to an urgent need to replenish supplies of tree seed across Ontario, Trees Ontario and partners delivered a series of public workshops for our planting delivery agents as well as members of the local communities:

- 4 Seed Forecasting Workshops—Spring 2010
- 2 Certified Seed Collector Workshops—Summer 2011
- 2 Growing Native Trees from Seed Workshops—Summer 2010
- 3 Seed Collection Mentoring Workshops—Fall 2010

Landowner workshops

This past year, Trees Ontario hosted 12 free tree planting workshops for landowners across the province with over 700 attendees.

Trees Ontario in the Community

In April 2010, Trees Ontario partnered with the Department of Foreign Affairs and International Trade, the Muskoka Heritage Foundation, Westwind Forest Stewardship Inc., and a group of community and student volunteers to ensure a green legacy for the 2010 G8 Summit. A total of 6,000 trees were planted on behalf of delegates who attended the G8 Leaders' Summit in Huntsville in June 2010.







In May 2010, Trees Ontario partnered with Zehrs to host the annual Community Planting Weekend with free events held across the province. Hundreds of local community volunteers attended and planted close to 3,000 trees.







Trees Ontario attended, displayed and presented at more than 100 events in over 65 Ontario communities in the past year. Major events included the Royal Agricultural Winter Fair, Green Living Show and the Canadian International Farm Show, with a total of more than 400,000 attendees. Other events included woodlot conferences, workshops, partner events and community fairs.

Green Leaders

Trees Ontario *Green Leaders* are landowners who are engaged with the environment and have contributed to our re-greening efforts by participating in the 50 Million Tree Program. Nominated by one of our planting delivery partners, Green Leaders are recognized for their leadership in tree planting initiatives and environmental stewardship of the land.

Tree Planting Delivery Partners


