It is just like in a real “marketplace”: suppliers and consumers meet and negotiate freely with each other about prices, quantities, and the quality of the products. The market economy has proved to be very efficient, but it is ethically acceptable only if it is a social market economy accompanied by a constitutional State. Hence, first of all, there must be clear rules guaranteed by the government, and, secondly, provisions must be made also for those who cannot offer anything in that marketplace, for ex- ample, because they have no job or no money. Furthermore there are human experiences that cannot be dealt with justly by the logic of the marketplace: suffering, sickness, and disability, for example. The fact that the economy functions according to its own laws does not mean that the laws of the marketplace are not subject to God's laws and commandments. Ethics is an essential component of good economic activity. Unethical business is in the long run economically wrong, also. It is equally true that uneconomical business, for instance wasting resources, is unethical.
