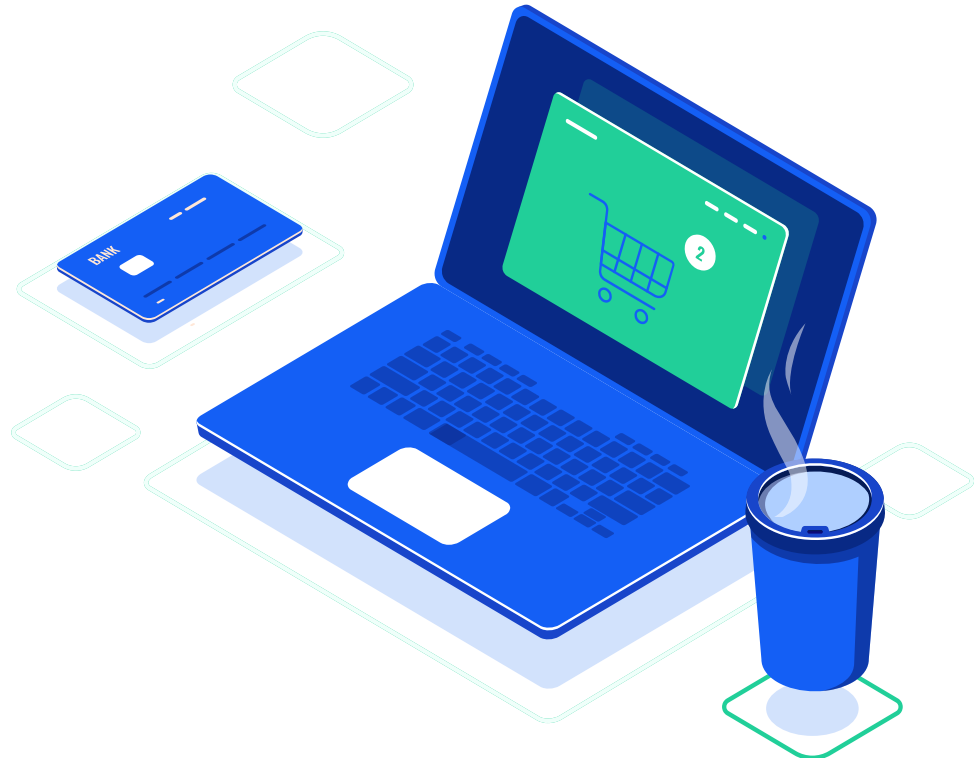

Background

RallyPay - Rally's one-click checkout solution - required a secure and compliant method to handle customers' sensitive payment information, ensure regulatory compliance, and support merchant integration with different payment service providers (PSPs). Rally promises secure storage of Personally Identifiable Information (PII) and payment data for shoppers across the Rally network. When co-founder and CTO Rok Knez started Rally, finding a reliable solution for handling and retaining this data and enabling secure customer vaulting was a top priority.

Challenge

“Our main challenge was building the functionality to recall credit card info, and then retaining it for merchants to serve to returning shoppers.”

Rally had two options:

1. Develop their own payment storage solution, which would require hiring additional specialist developers and dedicating significant time and resources to build incremental infrastructure alongside the Rally checkout platform, or
2. Outsource this functionality to a trusted vendor.

After considering both options, the Rally team realized that building an in-house solution would be the more time-consuming and costly option. They then assessed multiple vendors to identify one who could combine a secure vault with the flexibility needed for Rally's payment functionality to operate safely and effectively.

Solution

Rally identified VGS as their chosen vendor after confirming that the VGS Vault with its secure front-end data collection tools, flexible vaulting, and ability to proxy payment data to different payment service providers could meet Rally's needs.

They found the deployment of VGS's vault and tokenization services to securely collect and store customer data to be on-time and hassle-free. The implementation and support teams quickly resolved any queries, with a dedicated development resource to further ease the process.
