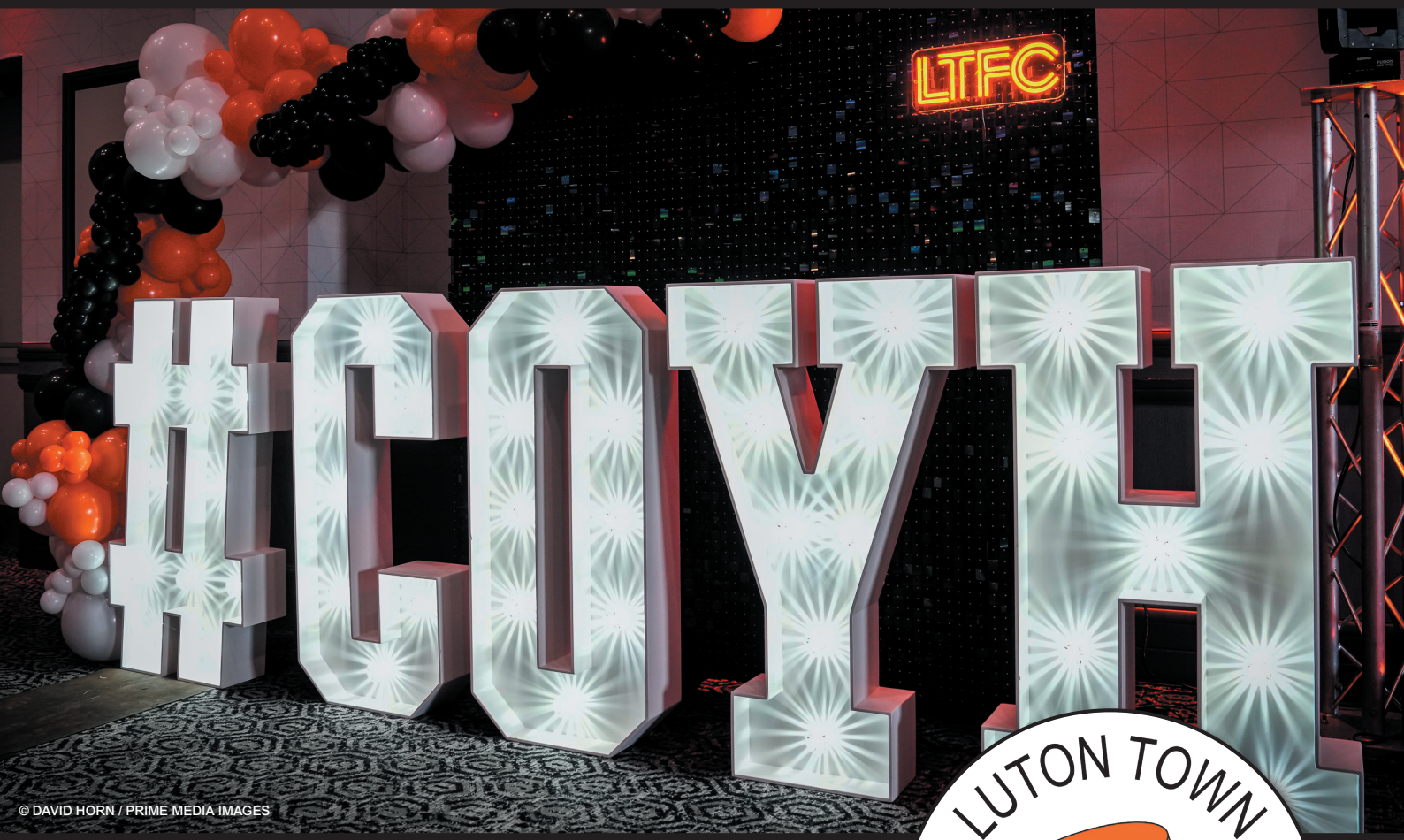

HOW DO I JOIN THE LUTON TOWN SUPPORTERS' TRUST?

The Trust are looking to streamline membership processes to make it simpler for you and to also save the ticket office having to do the extra work for us!

This year you won't be able to add trust membership to your season ticket but there are two ways you can pay your Trust membership:

1. **Print out the LTST Membership Form and direct debit mandate at A4 size (on page 4) and once completed, email it or post it to LTST as per the instructions on the form.** Your membership will be collected from your UK Bank account on the 1st July annually and you will be covered by the Bank Direct Debit guarantee scheme and be able to cancel your direct debit at any time with your bank.
2. **Visit www.lutontownsupporterstrust.com and click on 'Become a Member' and then follow the online instructions.** You will be offered both non-recurring one-off payment and recurring payment options. The non-recurring option does cause us additional administration and you need to renew your membership each year. Therefore, we would be very grateful if you could set up your payment on a recurring basis.

The Direct Debit Guarantee

- ❖ This Guarantee is offered by all Banks and Building Societies that accept instructions to pay Direct Debits.
- ❖ If there are any changes to the amount, date or frequency of your Direct Debit, FastPay Ltd Re TIL 2003 Ltd t/a Luton Town Supporters' Trust will notify you five working days in advance of your account being debited or as otherwise agreed. If you request FastPay Ltd Re TIL 2003 Ltd t/a Luton Town Supporters' Trust to collect a payment confirmation of the amount and date will be given to you at the time of the request.
- ❖ If an error is made in the payment of your Direct Debit by FastPay Ltd Re TIL 2003 Ltd t/a Luton Town Supporters' Trust or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- ❖ If you receive a refund you are not entitled to, you must pay it back when FastPay Ltd Re TIL 2003 Ltd t/a Luton Town Supporters' Trust asks you to.
- ❖ You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
