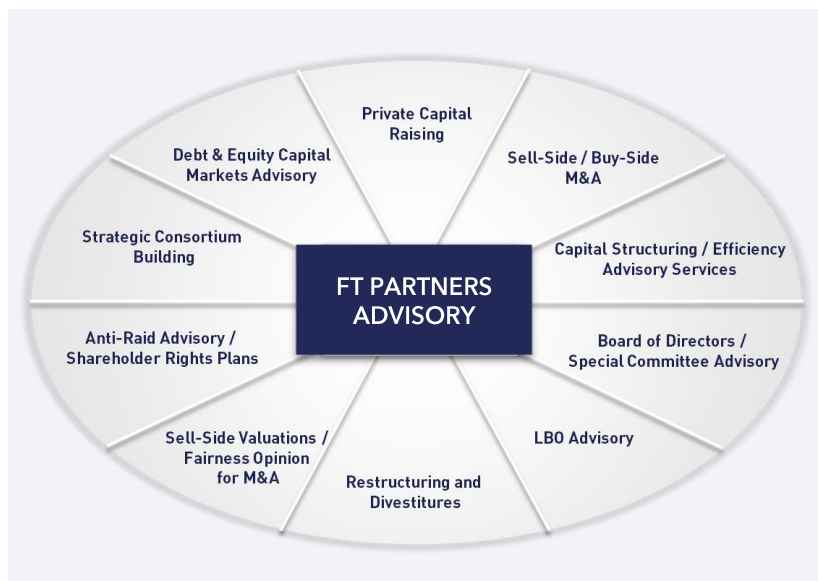

Transaction Summary

- On May 16, 2019, Goldman Sachs (NYSE:GS) announced that it has agreed to acquire United Capital Financial Partners for approximately \$750 million in cash
 - The transaction, which is expected to close in the third quarter of 2019, is Goldman Sachs' largest strategic acquisition in nearly 20 years ⁽¹⁾
- The United Capital acquisition will expand Goldman Sachs' wealth management business, which includes Ayco and Private Wealth Management and has nearly \$500 billion in total assets under supervision
 - Private Wealth Management is a leader in providing investment solutions and advice to high net worth individuals, families and endowments
 - Ayco provides investment management and financial counseling services to executives and employees at over 400 companies, including around 60 of the Fortune 100
- United Capital's Founder and CEO Joe Duran will be joining Goldman Sachs as part of the transaction, along with United Capital's team of advisors and employees
- The acquisition will also complement Marcus, Goldman's digitally-empowered consumer platform






