- On November 28, 2016, QuantGroup announced it had raised RMB 500 million (approximately \$73 million) in Series C financing led by Sunshine Insurance Group
 - Fosun Capital, Guosen Hongsheng Investment Co. and other undisclosed investors participated in the round
- Sunshine plans to work with QuantGroup on credit guarantees for its insurance products
- Fosun, which recently launched an Internet finance arm with online P2P lending and wealth management products, said it hopes QuantGroup will collaborate with its other FinTech portfolio companies

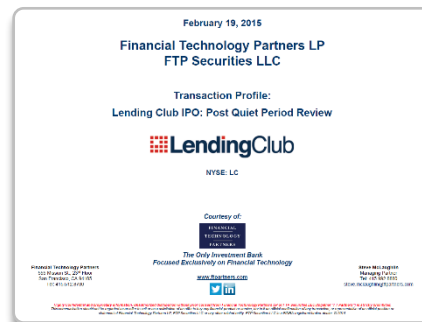

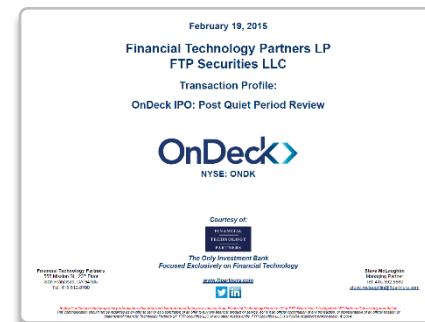

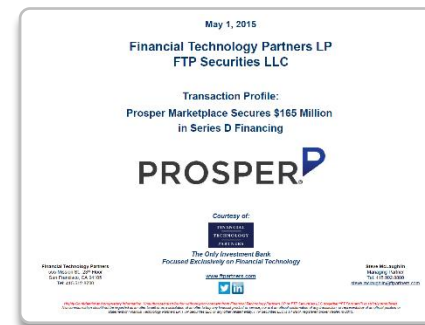
