- On April 30, 2015, Circle announced it has raised \$50 mm in financing led by Goldman Sachs and IDG Capital Partners
 - Existing investors Breyer Capital; General Catalyst Partners; Accel Partners; Oak Investment Partners; Fenway Summer; Digital Currency Group; and Pantera Capital also participated in the round
- The funding round values Circle at approximately \$200 mm, according to the Wall Street Journal
- With the completion of this round, Circle now allows users to hold, send and receive U.S. dollars as well as bitcoin instantly, securely and with no fees; enables settling transactions to be much cheaper than traditional online methods

Bitcoin Overview / Trends

Overview

- Bitcoin is a digital / virtual currency that is created and held electronically and uses peer-to-peer technology to operate without a central authority or bank
- Bitcoin is open-source nobody owns the bitcoin network and no merchant account is needed to receive bitcoins
- Means of acquiring bitcoin:
 - Payment for good or services
 - Earn bitcoins through mining
 - Buy bitcoins at a bitcoin exchange
- Bitcoin payments are transacted from a wallet app (e.g. Circle, Coinbase), either on one's laptop, PC, tablet or smartphone, by entering the recipient's address and amount
- Transactions are recorded on the blockchain, a public ledger of all bitcoin transactions that have ever been executed - it constantly grows as completed transactions / blocks are added to it with a new set of recordings
- Miners solve complex algorithms using special software / hardware in order to compile recent transactions onto the blockchain – miners who first solve the algorithms are issued a certain number of bitcoins in exchange
- Bitcoin users can pay a higher "voluntary fee" for faster confirmation of transactions and to compensate people who operate the bitcoin network

Trends

- Investment activity in the virtual currency space reached a record level in Q4 2014 – over \$120 million was invested in the space, a 158% increase over Q4 2013
- A growing number of merchants are accepting bitcoin there are at least a dozen merchants doing over \$1 billion in annual transactions accepting bitcoin
 - An estimated 100,000 merchants accepted bitcoin at the end of 2014
 - Major retailers accepting bitcoin include Microsoft, Amazon, Dell, DISH, Expedia, Overstock, Newegg and TigerDirect
- In May 2010, bitcoins were trading for approximately \$0.0045 a piece (approximately 222 Bitcoins per dollar); the price of bitcoin on May 1, 2015 was ~\$233
- Despite the recent downward trend in the price of bitcoin and high profile security breaches, daily transaction volume has increased reaching a record volume of over 120,000 transactions on January 14, 2015 (1)
- During 2014, global usage of digital currencies averaged ~\$50 million per day versus Visa and MasterCard's combined daily usage of ~\$32 billion per day, signaling that digital currencies still have a long way to go in order to reach broad, mainstream acceptance (2)




















Bitcoin Price Performance from 2012 - Present






Bitcoin Daily Number of Transactions from 2012 - Present
