



- On August 16, 2017, Options IT announced it secured \$100 million in financing from Bregal Sagemount
- Options IT plans on deploying the new capital to pursue growth initiatives, further invest in product innovations and widen its reach in global financial centers across the globe
  - Specifically, the Company plans to further invest in the employees and technology required to scale the business, while also providing multifaceted IT solutions and maintaining a customer centric engagement and support model
- Over the past few years, Options IT has grown rapidly and established itself as a leader in financial technology and managed IT solutions for capital markets and financial services firms
  - From 2014 to 2016, the Company's revenues in the United States increased more than 2x and the number of employees grew from 110 to 200 across the Company's offices in London, New York, Belfast, Hong Kong, Singapore, Toronto, Dublin and the Caribbean
- The \$100 million of growth capital provided by Bregal Sagemount is the first known source of financing for Options IT
