# **NerdWallet Raises \$64 mm in Financing**

### **Transaction Summary & NerdWallet Overview**

### **Transaction Summary**

- On May 11, 2015, NerdWallet secured \$64 million in equity financing led by Institutional Venture Partners; additional participation came from RRE Ventures and iGlobe Partners, an Asia-based investment firm
- NerdWallet also raised an additional \$36 million through a revolving loan facility with Silicon Valley Bank; the funding gives the Company more than \$100 million to solidify its standing as a strong player in online personal finance
- This is NerdWallet's only round of outside financing since being launched by its Co-Founder, Tim Chen, with \$800
- The round values NerdWallet in the mid-hundred millions, according to a source close to the transaction (1)
- Since the beginning of 2014, just eight startups have raised Series A funding rounds of \$50 million or more
- The Company is looking to grow its workforce from 200 to 300 employees by the end of the year and that hiring push could be done without touching the new financing (2)




