Transaction Summary

- On April 22, 2015, San Francisco and London-based SMB peer-to-peer lender Funding Circle announced that it had raised \$150 million in financing
 - DST Global led the round with participation from BlackRock, Baillie Gifford, Sands Capital and Temasek
 - According to the New York Times, the deal values the company at around \$1 billion (1)
- According to CEO Samir Desai, the Company will use the funds to expand operations in both the UK and the US. with the eventual goal of expanding into additional countries in Asia and Europe (1)
- The new funding round brings Funding Circle's total amount of capital raised to over \$273 million
 - Previous investors in Funding Circle include Index Ventures, Accel Partners, Union Square Ventures and Ribbit Capital and the UK Government
- Funding Circle was founded in 2010 and launched its services in the US in 2013 through the acquisition of Endurance Lending Network; to-date, the company has lent \$1 billion to more than 8,0000 small businesses globally
- Funding Circle's equity financing round follows other large, recent capital raises from Alternative Lenders including Prosper, SoFi, Avant Credit and Oportun in additional to the IPO's of both LendingClub and OnDeck

- Funding Circle is an online marketplace for small business loans
 - The platform allows investors (individual or entity) to bid on loans and directly lend money to small and medium-sized businesses
 - The marketplace offers asset-backed, secured, unsecured, property, working capital, and mortgage loan options
- The Company has offices in London and San Francisco
 - Funding Circle currently employees 100 people in its San Francisco office and 180 at its UK headquarters
- Since its launch in 2010, the platform has facilitated upwards of \$1 billion in loans to around 8,000 businesses
 - Funding Circle is currently facilitating \$60 million in loans a month in the UK and \$15 million a month in the US through its platform
- Loan sizes range from \$25,000 to \$500,000 with interest rates ranging from 6% to 21%
 - Funding Circle's loan default rate stands roughly at 1.4% of outstanding loans


