- **On May 14, 2018, Fair Square (marketer of the Olló credit card) announced it had secured a \$100 million growth equity investment from The Orogen Group**
 - Former Citigroup CEO Vikram Pandit now heads the investment firm, The Orogen Group, and is making a large bet on credit cards for the middle class
 - The investment follows Fair Square's initial 2016 equity raise of \$200 million led by financial services-focused private equity firm Pine Brook
- **With this new investment, Fair Square will continue its growth trajectory and further its goal of providing credit to Americans who are often not adequately served by major financial brands**
 - Fair Square claims the investment will allow the Company to meet the high demand for the Olló card well into the future

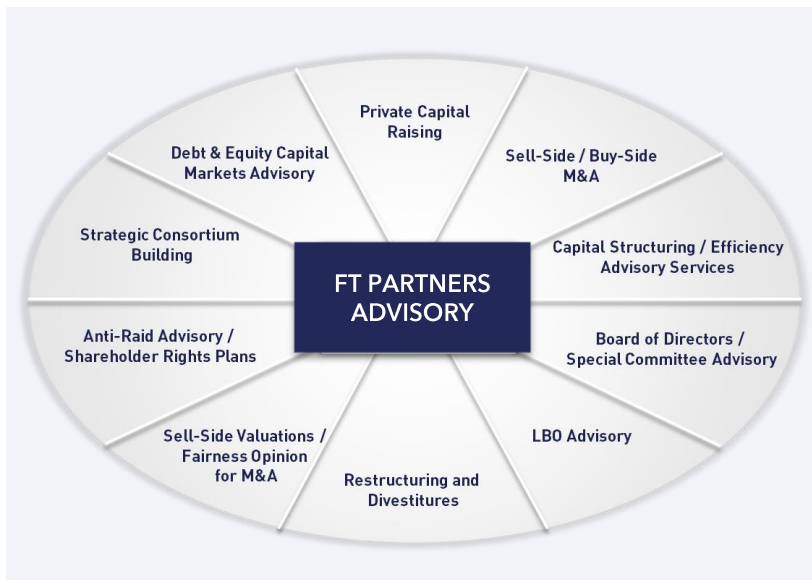
