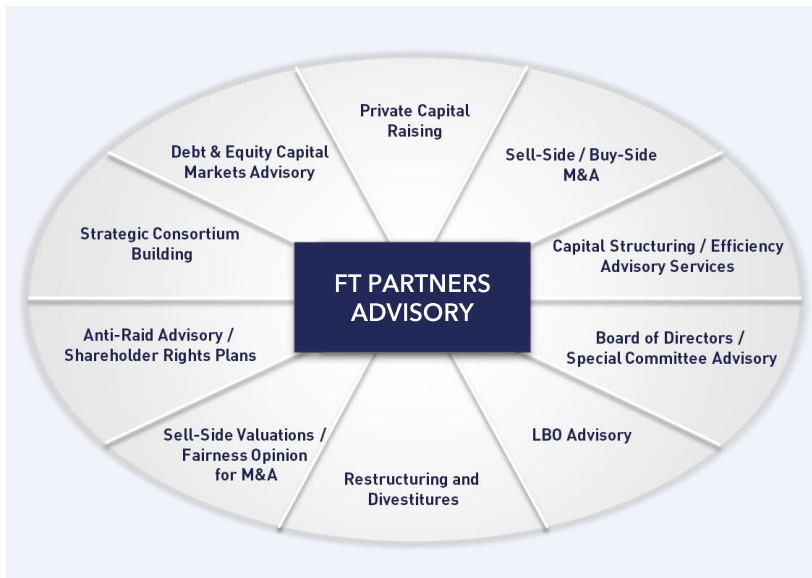

### Transaction Summary

- **On January 31, 2018, nCino announced it had completed a funding round led by Salesforce Ventures**
  - According to its Form D filing, nCino raised approximately \$51 million of equity in this latest round
  - An existing investor also participated in this investment round
  - nCino's existing shareholders include Insight Venture Partners and Wellington Management
- **In parallel with the announcement of the raise, the Company also announced its customer portfolio now includes more than 180 financial institutions in multiple countries**
  - The customer portfolio includes 10 of the top 30 U.S. banks by asset size
- **This investment will accelerate the Company's growth initiatives and further develop its Bank Operating System**
  - nCino's Bank Operating System integrates with financial institutions' core and transaction systems, while simultaneously replacing point solutions and manual processes

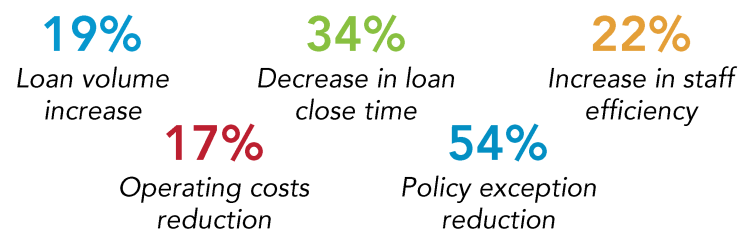
