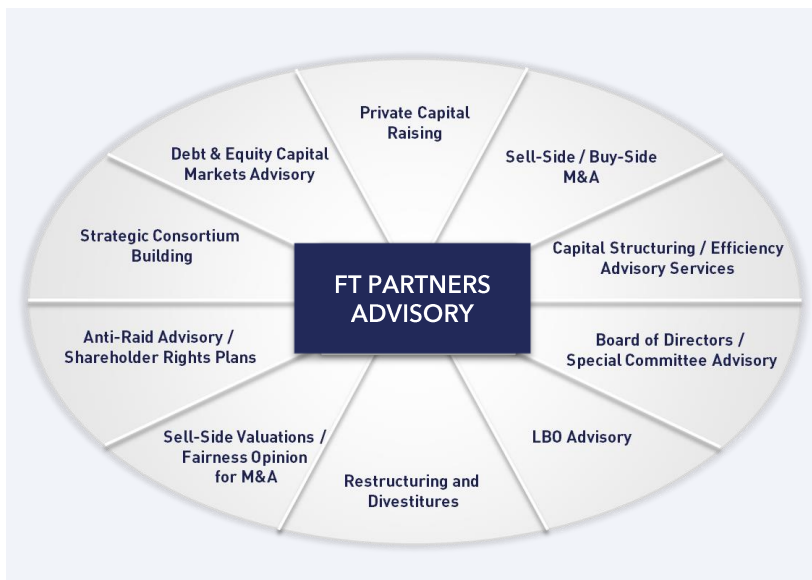

Transaction Summary

- On July 24, 2018, Metromile announced it had secured \$90 million in Series E financing co-led by Tokio Marine Holdings and Intact Financial
 - Existing and new investors also participated in this round, including NEA, Index, Future Fund and Section 32
- The Company plans to use the funds to expand pay-per-mile insurance and simplify every step of the insurance experience through the use of artificial intelligence (AI) in claims processing
- In addition, Stacy J. Smith was appointed as Independent Director to Metromile's Board of Directors
 - Smith previously served at Intel Corporation as the executive vice president of Manufacturing, Operations and Sales and was also the longtime CFO

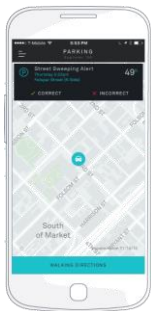

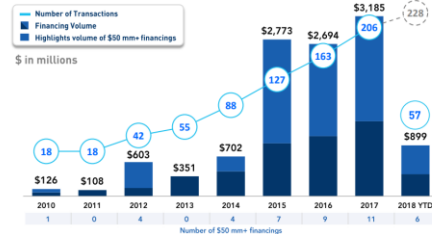

INSURTECH FINANCING ACTIVITY: ANNUALLY

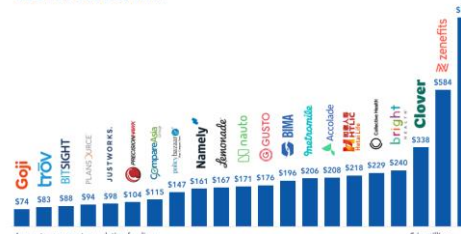
InsurTech Private Company financing volume and number of transactions rose to a record level in 2017, but 2018 is already tracking at a higher annualized rate

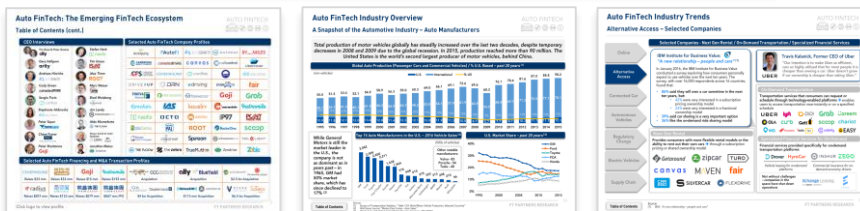

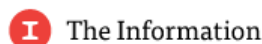
