Transaction Summary

- On July 11, 2018, Tiger Brokers announced that it had secured approximately \$80 million in Series C financing led by Prospect Avenue Capital, Orient Hontai Capital and **Oceanpine Capital**
 - This transaction values the Company at \$1.06 billion, according to China Money Network (1)
- Tiger Brokers provides a trading app that allows Chinese investors to invest in U.S., Hong Kong and China A shares
- The additional capital will be used to support R&D, boost technology development and acquire new talent
- Trading volume through Tiger Brokers reached \$18 billion in 2016 and \$75 billion in 2017 (1)
- Prior funding rounds saw participation from a total of over 20 strategic investors (2)

- On May 29, 2018, Moneyfarm announced it has raised £40 million in a Series B financing round led by Allianz Asset Management, the investment arm of global insurer Allianz
 - Venture Capital firm Endeavor Catalyst and Italian finance firm Fondazione di Sardegna joined the round as new investors, with further funding from existing backers United Ventures and Cabot Square Capital
 - Allianz first invested in Moneyfarm in September 2016

 - Moneyfarm provides bespoke automated advice and discretionary portfolio management with exposure to multiple asset classes, through its diversified ETF-based portfolios
