# **InvestCloud Raises \$45 mm in Series B Financing**

### Transaction Overview

#### **Transaction Overview**

- On October 13, 2015 InvestCloud announced it has raised \$45 mm in funding led by FTV Capital
  - Richard Garman, Managing Partner at FTV Capital, has joined InvestCloud's Board of Directors
  - This transaction brings InvestCloud's total funding to-date to approximately \$54.1 mm
  - According to the Company, InvestCloud became profitable last year and is on track for profitability this year as well

#### **Strategic Rationale**

- InvestCloud will used the additional capital to buy out certain existing shareholders, further invest in the Company's platform and functionality, enhance its customer service base and expand the Company's global outreach
  - \$30 mm of the capital raise will be used to buy out stock owned by CEO John Wise, President Colin Close, Series A investor Kern Whelan Capital, as well as other small shareholders
  - \$15 mm of its stock sale will help the Company to expand into Europe and enhance its platform; the Company will be opening offices in London and Zurich in 2016


