R3 Raises \$107 million in Financing



Transaction Overview

Transaction Summary

- **On May 23, 2017, R3 raised \$107 mm in financing from a consortium of institutional investors**
 - Lead investors include SBI Group, Bank of America Merrill Lynch, HSBC, Intel and Temasek; additional participation from ING, Banco Bradesco, Itaú Unibanco, Natixis, Barclays, UBS and Wells Fargo, among over 40 total firms
 - Goldman Sachs and Santander both dropped out of the consortium
- This round of funding marks the first two parts of a three-part “Series A” round
 - The first two parts were only open to members of R3’s consortium
 - The Company is expected to raise the final portion later this year
- **R3 represents the largest consortium of global financial institutions focused on developing commercial applications for distributed ledger technology**
- **The Company will use the financing to accelerate development of its technology and grow strategic partnerships for project deployment**⁽¹⁾
 - R3 has its own proprietary ledger and applications, but also supports an infrastructure network for financial services firms and technology companies to create their own ledger-based applications or services
- **R3’s technology is focused on business applications like verifying transactions between banks, or automating processes like the establishment of the London Interbank Offer Rates**

Corda is the only distributed ledger platform to support multiple consensus providers employing different algorithms on the same network, enabling compliance with local regulations



Easy integration

Corda is designed to make integration and interoperability easy: query the ledger with SQL, join to external databases, perform bulk imports, and write contracts in established modern languages

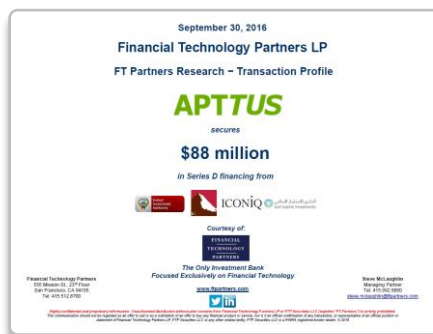
