- On January 22, 2015, Raise.com announced that it had secured \$56 mm in a Series B financing round led by New Enterprise Associates at "just shy of a billion" dollar valuation (1)
- Additional investors included: Bessemer Venture Partners (BVP), the Pritzker Organization and Listen Ventures
- This funding round will be used to continue to grow the Company as it works to establish itself as a leader in the gift card marketplace
- New Enterprise Associates' General Partner, Tony Florence, will join Raise.com's Board of Directors to provide mentorship and guidance as the company continues its rapid growth
- With this round of funding, the total amount raised by the Company is now over \$81 million


Overview of Raise.com Gift Card Buying and Selling Process

Buying Process




1. Browse Inventory of Gift Cards for Sale

3. Check Out


Once selection has been made, buyer inputs billing and shipping information and upon confirmation, gift card is delivered
