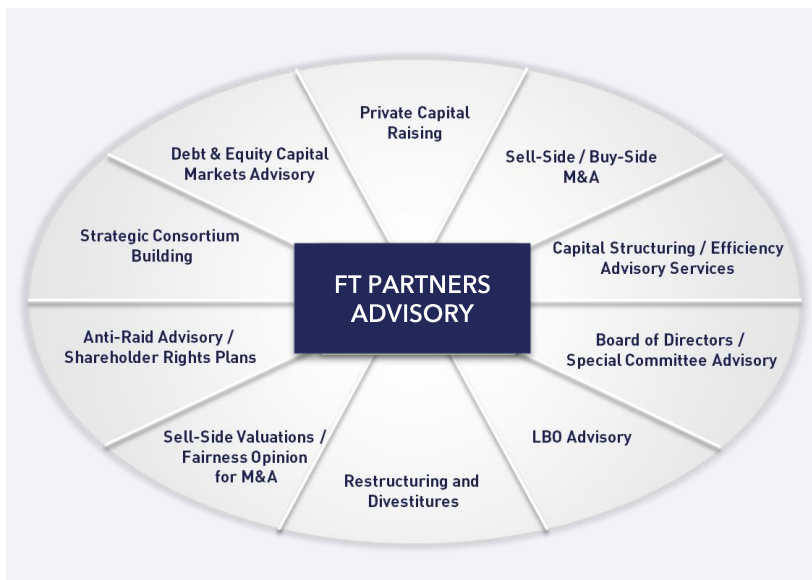

Creditas is a brazil-based online secured loan platform

- On April 17, 2018, Creditas announced it had extended its original Series C of \$50 million to \$55 million with a further investment of \$5 million from Santander InnoVentures and Amadeus Capital Partners
 - The Company's original Series C round was led by Vostok Emerging Finance in December 2017
- The Company intends to use the new funds to further develop new products and expand into new markets

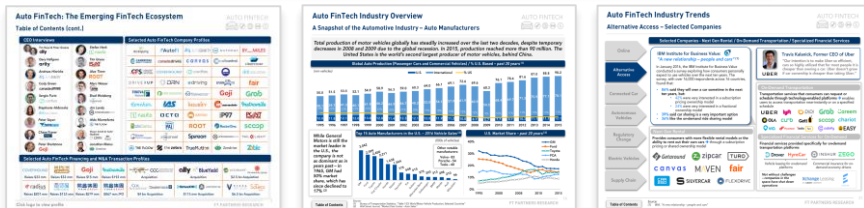
