## Transaction Summary

### Transaction Summary

- On July 24, 2018 BlockFi announced it had closed a \$52.5 million equity and lending capital financing round led by Galaxy Digital and joined by earlier investors ConsenSys Ventures and PJC
- \$50 million of the capital is a loan purchase facility and the remaining \$2.5 million is an equity investment from Galaxy Digital and earlier backers
- Follows \$1.55 mm seed round in February 2018 led by ConsenSys Ventures
  - Seed round investors also included Alumni Ventures Group, Kenetic Capital, Purple Arch Ventures, PJC, and SoFi
- This is the industry's first institutional investment in crypto asset-backed lending
- As part of the investment Chris Ferraro, Head of Principal Investments at Galaxy Digital, will be joining BlockFi's board of directors
- BlockFi plans to ramp up marketing and business development efforts in order to make the platform available to more people, in more cryptocurrencies, and in more geographies in the near future
- BlockFi sets itself apart by combining the lowest rates for crypto-to-USD borrowing with institutional benefits and has the most U.S. state lending licenses in the country
