- On February 6, 2019, Raisin announced that it has closed a Series D financing round of \$114 million
 - Existing investors Index Ventures, PayPal, Ribbit Capital and Thrive Capital all participated in the round
 - The latest round of financing brings Raisin's total capital raised to \$200 million
- The Company also announced that it has brokered more than \$11 billion in deposits to 62 partner banks and earned savers \$90 million in earned interest
- The new capital will be used for strategic acquisitions and further internationalization
 - Following its launches in the Netherlands and the UK last year, Raisin is planning to add at least two additional markets to its platform this year
 - Raisin will also expand its international team and extend its line of investment products

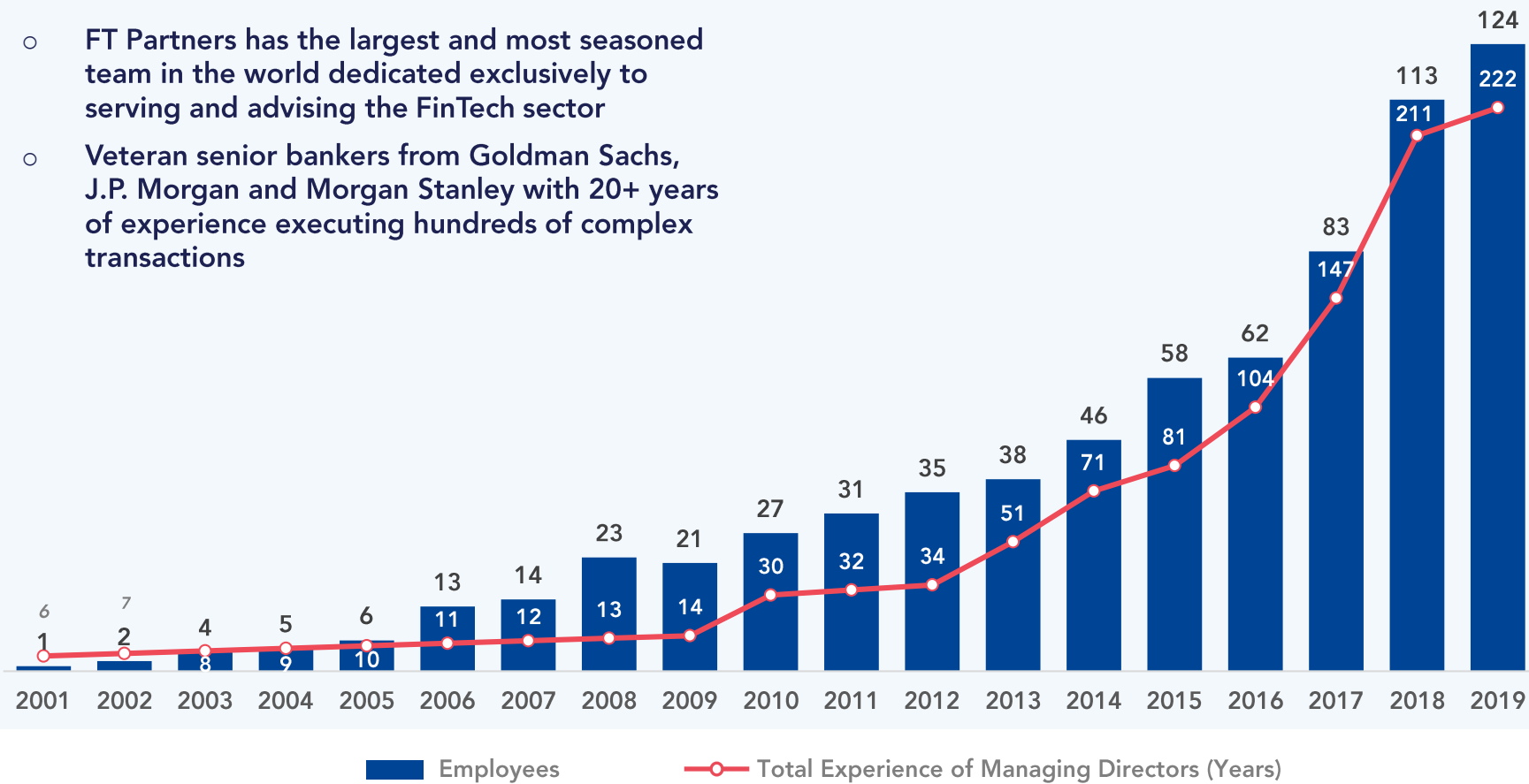
