- **On March 21, 2018, CommonBond announced it had secured \$50 million in Series D financing led by Fifth Third Bancorp**
 - New investors, First Republic Bank and Columbia Seligman Investments, participated in the round
 - Existing investors, Neuberger Berman, August Capital and NYCA also participated in the Series D investment
 - This round brings CommonBond's total equity funding up to more than \$130 million
 - CommonBond has also secured over \$3 billion in lending capital, to date
- **CommonBond intends to use the new capital to accelerate its growth and further invest in its technology platform**
 - This funding follows a year of significant growth for the Company – in 2017, CommonBond saw a year-over-year revenue increase of 250%
 - Through the end of 2017, CommonBond had only experienced two credit defaults ever
