Transaction Summary

- On November 8, 2017, WeLab announced it had raised \$220 million in a Series B+ round of equity and debt financing
 - Alibaba Entrepreneurs Fund, International Finance Corporation (IFC), Credit Suisse and others participated in this round
 - Other early investors in WeLab include Khazanah Nasional, ING Bank, Guangdong Financial Technology Group, Yuri Milner, Iconiq Capital, TOM Group and Sequoia Capital
 - Following WeLab's \$160 million Series B round in 2016, this investment brings WeLab's total capital raised to \$425 million
- The Company intends to use the new capital to further develop its credit technology and expand outside of China
- Founded in 2013, WeLab now has 25 million users and has processed \$28 billion in loans
