What is the purpose of this update?

This document tells you how the Sharesies Smartshares Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the [Financial Markets Conduct Act 2013](#). This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the SuperLife Balanced Fund. The fund is designed for investors that want a balance between stability of returns and growth of their investment over the long term. The fund provides exposure to a diverse mix of growth and income assets.

What are the risks of investing?

Risk indicator for the Sharesies Smartshares Balanced Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?


Example of how this applies to an investor

Billy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Billy received a return after fund charges were deducted of \$1,006.26 (that is 10.06% of his initial \$10,000). Billy did not pay any other charges. This gives Billy a total return after tax of \$922.58 for the year.


This shows the types of assets that the fund invests in

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
