Fund update for the quarter ending 30 June 2024

This fund update was first made publicly available on 29 July 2024.

What is the purpose of this update?

This document tells you how the Sharesies Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the **Financial Markets Conduct Act 2013**. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the Pathfinder Ethical Growth Fund, an ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

What are the risks of investing?

Risk indicator for the Sharesies Pathfinder Ethical Growth Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

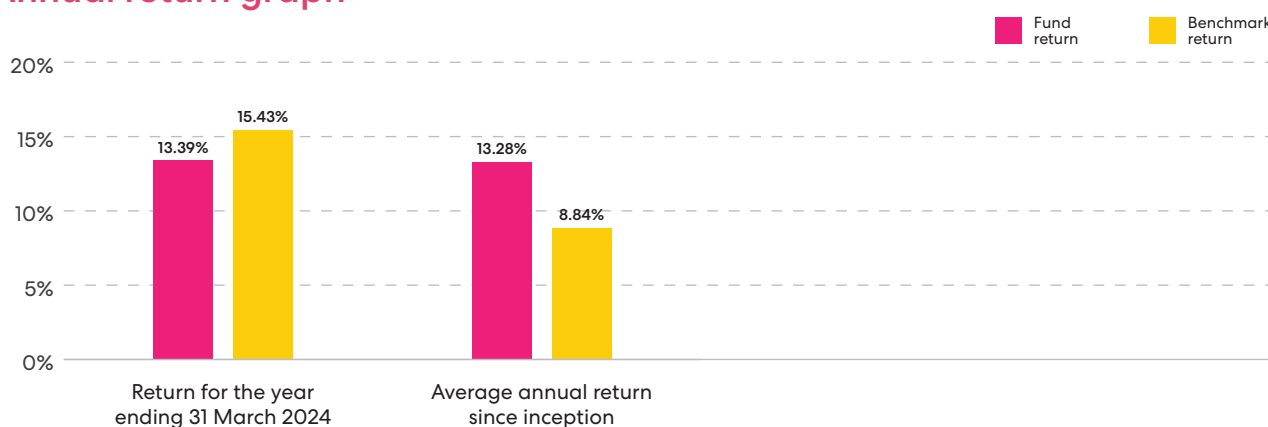


How has the fund performed?

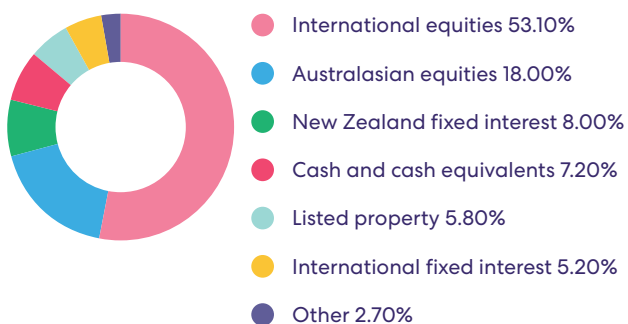
Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$1,311.21 (that is 13.11% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$1,242.47 for the year.

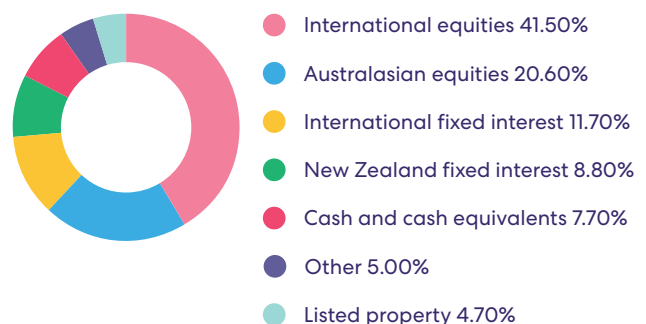
This shows the types of assets that the fund invests in

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 April 2023 and fund returns thereafter.
2. As the Sharesies Pathfinder Ethical Growth Fund only started accepting contributions on 25 January 2023, historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
