
## Description of this fund

The fund invests wholly in the Pie Global Growth 2 Fund, whose objective is to generate capital growth which outperforms the market index by investing predominantly in listed international large companies.

# What are the risks of investing?

Risk indicator for the Sharesies Pie Global Growth 2 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




# How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 September 2024.

## Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$2,409.91 (that is 24.1% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$2,199.35 for the year.

#### **Notes**

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
