What is the purpose of this update?


Description of this fund

The fund invests wholly in the Pie Global Growth 2 Fund, whose objective is to generate capital growth which outperforms the market index by investing predominantly in listed international large companies.

What are the risks of investing?

Risk indicator for the Sharesies Pie Global Growth 2 Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2024.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$1,551.14 (that is 15.51% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$1,440.35 for the year.

Notes

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 April 2023 and fund returns thereafter.
- 2. As the Sharesies Pie Global Growth 2 Fund only started accepting contributions on 25 January 2023, historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
