# What is the purpose of this update?

This document tells you how the Sharesies Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the <u>Financial Markets Conduct Act 2013</u>. This information is not audited and may be updated.

## Description of this fund

The fund invests wholly in the SuperLife Growth Fund. The fund is designed for investors that want a growth investment option that aims to achieve higher returns over the long term, with more ups and downs along the way. The fund provides exposure to a diverse range of domestic and global growth assets.

# What are the risks of investing?

# Example of how this applies to an investor

Sophie had \$10,000 in the fund on 25 January 2023 (the date the fund started) and did not make any further contributions. At the end of the period to 30 June 2023, Sophie received a return after fund charges were deducted of \$369 (that is 3.69% of her initial \$10,000). This gives Sophie a total return after tax of \$379.06 for the period from 25 January 2023 to 30 June 2023.

#### **Notes**
