### **Sharesies Pie Global Growth 2 Fund**

#### Fund update for the quarter ending 31 March 2024

This fund update was first made publicly available on 24 April 2024.

### What is the purpose of this update?

This document tells you how the Sharesies Pie Global Growth 2 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the <u>Financial Markets Conduct Act 2013</u>. This information is not audited and may be updated.

## Description of this fund

The fund invests wholly in the Pie Global Growth 2 Fund, whose objective is to generate capital growth which outperforms the market index by investing predominantly in listed international large companies.

# What are the risks of investing?

Risk indicator for the Sharesies Pie Global Growth 2 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

### Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$1,462.64 (that is 14.63% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$1,462.64 for the year.

#### Notes

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - As the Sharesies Pie Global Growth 2 Fund only started accepting contributions on 25 January 2023, historical fee information is not available.
