What is the purpose of this update?


Description of this fund

The fund Invests wholly in a US exchange traded fund (ETF) that provides exposure to large US companies. Aims to achieve returns similar to its benchmark, the Morningstar US Target Exposure TR NZD Index.

What are the risks of investing?

Risk indicator for the Sharesies US500 Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor


Billy had \$10,000 in the fund on 20 March 2025 (the date the fund started) and did not make any further contributions. At the end of the period to 31 December 2025, Billy received a return after fund charges were deducted of \$2,228.64 (that is 22.29% of his initial \$10,000). Billy did not pay any other charges. This gives Billy a total return after tax of \$2,125.58 for the period from 20 March 2025 to 31 December 2025.


This shows the types of assets that the fund invests in

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
