What is the purpose of this update?

This document tells you how the Sharesies Smartshares Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the <u>Financial Markets Conduct Act 2013</u>. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the SuperLife Balanced Fund. The fund is designed for investors that want a balance between stability of returns and growth of their investment over the long term. The fund provides exposure to a diverse mix of growth and income assets.

What are the risks of investing?

Risk indicator for the Sharesies Smartshares Balanced Fund¹


Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sophie had \$10,000 in the fund on 25 January 2023 (the date the fund started) and did not make any further contributions. At the end of the period to 31 March 2023, Sophie incurred a loss after fund charges were deducted of -\$9.04 (that is -0.09% of her initial \$10,000). This gives Sophie a total loss after tax of -\$9.04 for the period from 25 January 2023 to 31 March 2023.

Notes

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 28 February 2023 and fund returns thereafter.
- 2. As the Sharesies Smartshares Balanced Fund only started accepting contributions on 25 January 2023, historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
