
## Description of this fund

The fund invests wholly in the Pie Global Growth 2 Fund, whose objective is to generate capital growth which outperforms the market index by investing predominantly in listed international large companies.

# What are the risks of investing?

Risk indicator for the Sharesies Pie Global Growth 2 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




## How has the fund performed?

## Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$1,343.93 (that is 13.44% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$1,519.21 for the year.

#### **Notes**

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
