This fund update was first made publicly available on 28 April 2023.

What is the purpose of this update?

This document tells you how the Sharesies Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the **Financial Markets Conduct Act 2013**. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the Pathfinder Ethical Growth Fund, an ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

What are the risks of investing?

Risk indicator for the Sharesies Pathfinder Ethical Growth Fund¹

Example of how this applies to an investor

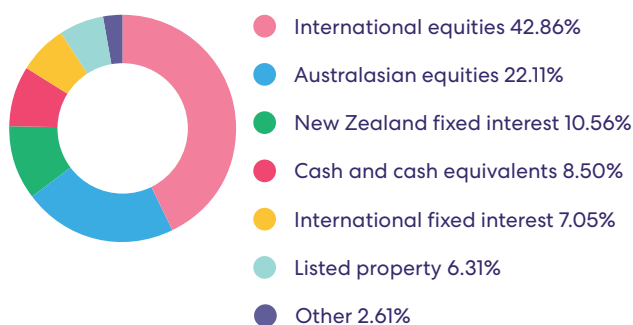
Sophie had \$10,000 in the fund on 25 January 2023 (the date the fund started) and did not make any further contributions. At the end of the period to 31 March 2023, Sophie incurred a loss after fund charges were deducted of -\$21.58 (that is -0.22% of her initial \$10,000). This gives Sophie a total loss after tax of -\$41.30 for the period from 25 January 2023 to 31 March 2023.



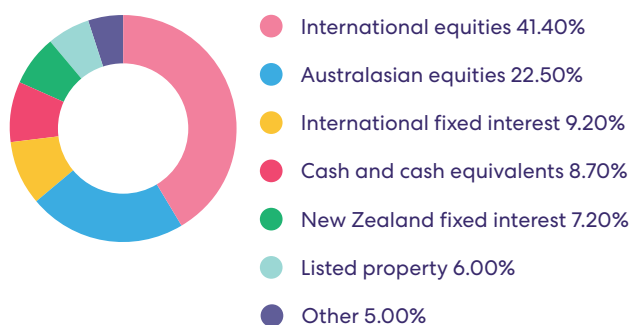

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. 2. As the Sharesies Pathfinder Ethical Growth Fund only started accepting contributions on 25 January 2023, historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
