What is the purpose of this update?

This document tells you how the Sharesies Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund invests wholly in the Pathfinder Ethical Growth Fund, an ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

What are the risks of investing?

Example of how this applies to an investor

Sophie had \$10,000 in the fund on 25 January 2023 (the date the fund started) and did not make any further contributions. At the end of the period to 31 March 2023, Sophie incurred a loss after fund charges were deducted of -\$21.58 (that is -0.22% of her initial \$10,000). This gives Sophie a total loss after tax of -\$41.30 for the period from 25 January 2023 to 31 March 2023.

Notes
