
Description of this fund

The fund invests wholly in the Pathfinder Ethical Growth Fund, an ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

What are the risks of investing?

Risk indicator for the Sharesies Pathfinder Ethical Growth Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sophie had \$10,000 in the fund on 25 January 2023 (the date the fund started) and did not make any further contributions. At the end of the period to 30 June 2023, Sophie received a return after fund charges were deducted of \$532 (that is 5.32% of her initial \$10,000). This gives Sophie a total return after tax of \$522.07 for the period from 25 January 2023 to 30 June 2023.
