Fund update for the quarter ending 30 September 2025

This fund update was first made publicly available on 20 October 2025.

What is the purpose of this update?

This document tells you how the Sharesies Smartshares Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the <u>Financial Markets Conduct Act 2013</u>. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the SuperLife Conservative Fund. The fund is designed for investors that want a conservative investment option that aims to provide more stable returns over the short to medium term. The fund provides exposure to a diverse range of domestic and global income assets.

What are the risks of investing?



How has the fund performed?

What fees are investors charged?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$775.38 (that is 7.75% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$657.83 for the year.

Notes

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 April 2023 and the fund's actual returns thereafter.
- 2. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
