Sharesies Pie Global Growth 2 Fund

Fund update for the quarter ending 30 June 2023

This fund update was first made publicly available on 25 July 2023.

What is the purpose of this update?

This document tells you how the Sharesies Pie Global Growth 2 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the <u>Financial Markets Conduct Act 2013</u>. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the Pie Global Growth 2 Fund, whose objective is to generate capital growth which outperforms the market index by investing predominantly in listed international large companies.

What are the risks of investing?

Risk indicator for the Sharesies Pie Global Growth 2 Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

Sophie had \$10,000 in the fund on 25 January 2023 (the date the fund started) and did not make any further contributions. At the end of the period to 30 June 2023, Sophie received a return after fund charges were deducted of \$315 (that is 3.15% of her initial \$10,000). This gives Sophie a total return after tax of \$331.97 for the period from 25 January 2023 to 30 June 2023.

Notes

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
