Fund update for the quarter ending 31 March 2025

This fund update was first made publicly available on 29 April 2025.

What is the purpose of this update?

This document tells you how the Sharesies Milford Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the **Financial Markets Conduct Act 2013**. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the Milford Aggressive Fund. The fund is designed to maximise capital growth over the minimum recommended investment timeframe. Primarily invests in international equities, with a moderate allocation to Australasian equities.

What are the risks of investing?

Risk indicator for the Sharesies Milford Aggressive Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

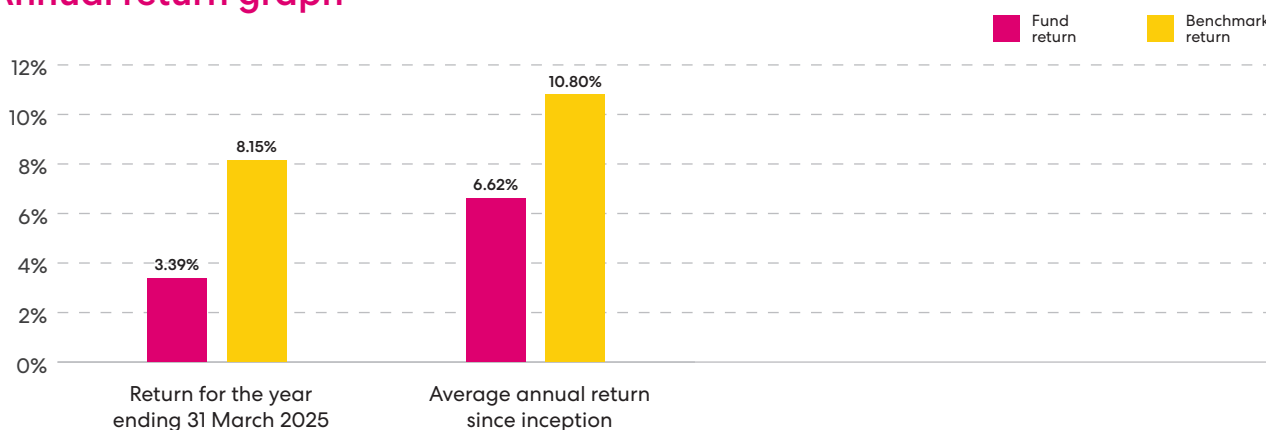


How has the fund performed?

	Past year
Annual return (after deductions for charges and tax)	2.60%
Annual return (after deductions but before tax)	3.39%

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2025.

Investors in the Sharesies Milford Aggressive Fund are charged fund charges which are:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$338.93 (that is 3.39% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$259.73 for the year.

Notes
