### Fund update for the quarter ending 31 December 2024

### What is the purpose of this update?

This document tells you how the Sharesies Milford Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 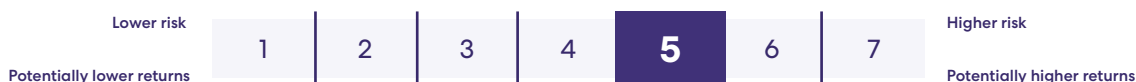
### Description of this fund

The fund invests wholly in the Milford Aggressive Fund. The fund is designed to maximise capital growth over the minimum recommended investment timeframe. Primarily invests in international equities, with a moderate allocation to Australasian equities.

### What are the risks of investing?

Risk indicator for the Sharesies Milford Aggressive Fund<sup>1</sup>

## Example of how this applies to an investor

Katy had \$10,000 in the fund on 29 February 2024 (the date the fund started) and did not make any further contributions. At the end of the period to 31 December 2024, Katy received a return after fund charges were deducted of \$964 (that is 9.64% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$895.69 for the period from 29 February 2024 to 31 December 2024.

### Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. 2. As the Sharesies Milford Aggressive Fund only started accepting contributions on 29 February 2024, historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
