Streamline your business account opening at Elevations Credit Union with this checklist. You may open your account online or by appointment with your local branch.

REQUIRED BUSINESS DOCUMENTS: ALL ENTITIES	ADDITIONAL REQUIRED DOCUMENTS:
☐ Full legal name of business, along with any registered DBA name	MULTI-MEMBER LLC
	☐ Articles of Organization
☐ All businesses must disclose their beneficial owner(s) or control person(s), per federal law. Beneficial owners are defined as individuals owning 25% or more of the business. A control person is any individual exercising substantial control over the business. For each beneficial owner or control person, we will collect the following:	<ul> <li>Operating Agreement, which must include the names of authorized individuals</li> </ul>
	☐ If authorized individuals are not specified in the Operating Agreement, we may require current meeting minutes or board resolution that identifies all authorized signers and their titles
<ul> <li>Full name, SSN or ITIN, home address, valid government-issued identification, email, and phone number.</li> </ul>	ADDITIONAL REQUIRED DOCUMENTATION: CORPORATION
☐ If the business does not have a separate EIN, an individual's Social Security Number or Individual Tax Identification Number must be provided for allowable business types (sole proprietors and single member LLCs)	☐ Article of Incorporation
