## Late Payment Fee:

\$15.00 or the amount of the required minimum payment, whichever is less, if you are 10 or more days late in making a payment.

#### Balance Transfer Fee (Finance Charge):

3.00% of each balance transfer.

## Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.

# Returned Convenience Check Fee:

\$25.00 or the amount of the returned convenience check, whichever is less.
