

# TELUS Rewards 2025 Holiday Calendar Campaign

## CONTEST RULES

**2025 Holiday Calendar** (the “**Contest**”) is being conducted by TELUS (hereinafter referred to as the “**Contest Sponsor**”) and shall be construed and evaluated according to applicable Canadian law. Entry in this Contest constitutes each entrant’s acceptance of, and agreement to be legally bound by, these Official Rules and Regulations (the “**Rules**”).

### 1. ELIGIBILITY

- a. To be eligible for this Contest, an individual must be a legal resident of Canada who is over the legal age of majority in his/her jurisdiction of residence at the time of entry. Entrants must be an existing TELUS Home Services or Mobility customer. Employees, representatives and agents of Contest Sponsor, Prize Supplier(s), and each of their respective affiliates, subsidiaries, related entities, advertising and promotional agencies, and any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfillment of the Contest (collectively, the “Contest Parties”), and the household members (whether related or not) and/or the immediate family members of any of the Contest Parties, are eligible to participate in the Contest.
- b. The Contest Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Contest Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual’s eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry and/or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Contest Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the Contest Sponsor’s interpretation of the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Contest Sponsor within the timeline specified by the Contest Sponsor may result in disqualification of the applicable entrant in the sole and absolute discretion of the Contest Sponsor. All personal and other information requested by and supplied to the Contest Sponsor for the purpose of this Contest must be truthful, complete, accurate and in no way misleading. The Contest Sponsor reserves the right to disqualify any Entry or entrant in its and their sole discretion, should any Entry or entrant at any stage supply untruthful, incomplete, inaccurate, or misleading personal details and/or information.

### 2. CONTEST PERIOD

The Contest opens at 12:00:00 a.m. Eastern Time (“ET”) on December 1, 2025 and closes at 11:59:59 p.m. ET on December 25, 2025 with one (1) daily prize available to be won each day during the contest period (the “Contest Period”). Entrants have the opportunity to receive a maximum of twenty-five (25) daily entries into the \$10,000 Grand Prize draw. All daily prize entries must be received by 11:59:59 p.m. ET on each contest day until December 25, 2025 (the “Entry Deadline”).

### 3. **HOW TO ENTER**

No purchase necessary. Entrants must:

- (i) be existing TELUS Home Services or Mobility customer; and
- (ii) must submit their daily entry by logging into their TELUS Rewards account at [www.telus.com/my-rewards](http://www.telus.com/my-rewards) between December 1, 2025 to December 25, 2025.

Entrants will receive one (1) entry per each contest day.

### 4. **THE PRIZE**

There will be one (1) Grand Prize winner. Winner will receive the following prize:

- Ten (10) \$1,000 SKIP e-Gift Cards (total retail value is \$10,000)

#### **Daily Prizes**

There will be twenty-five (25) daily Surprise & Delight prizes (one per day from December 1 to December 25) awarded. The specific prize available for each day will be revealed on the Holiday Calendar.

The approximate value of the daily prizes range from \$329-\$7000. Daily prizes and applicable terms and conditions will be displayed on the [www.telus.com/rewards](http://www.telus.com/rewards). The total approx. retail value of the daily prizes is \$100,000.

The prize is subject to all limitations and conditions that may be set by the prize provider. Please refer to the terms and conditions located on [www.telus.com/rewards](http://www.telus.com/rewards) for additional limitations around each prize.

If the winner is unable to accept the Prize for any reason, Prize will be forfeited and no substitute prize will be provided. No telephone contact or correspondence will be entered into except with the winning entrant. TELUS reserves the right to substitute the prize which is, in their sole opinion, a prize of equivalent value and/or to terminate or withdraw this contest at any time. The chances of winning are dependent upon the total number of eligible entries received.

#### **WestJet Prizes**

Daily Surprise & Delight prizes for WestJet All Inclusive Vacations and WestJet Gold Tier Status Upgrade (together, the "WestJet Prizes") are provided by WestJet as a Prize Supplier

for the Contest, and are subject to at all times (i) the terms and conditions outlined in Schedule “A”; (ii) the [WestJet Rewards Terms and Conditions](#); and (iii) the [WestJet Privacy Statement](#).

## 5. **ELIGIBLE WINNER SELECTION**

- The odds of being selected as the potential winner are dependent upon the number of eligible Entries submitted and received in accordance with these Rules. On or about the draw date, at approximately 12:00pm [noon] ET, a data pull for all eligible Entries will be completed. The draw schedule for the Contest is as follows:
  - Week 1 (December 1-7, 2025): Draws conducted December 8, 2025
  - Week 2 (December 8-14, 2025): Draws conducted December 15, 2025
  - Week 3 (December 15-21, 2025): Draws conducted December 22, 2025
  - Week 4 (December 22-25, 2025): Draws conducted January 5, 2026
  - Grand Prize: Draw conducted January 5, 2026
- Limit of one (1) daily Prize entry per email, per person and per household for the duration of the Contest. Entrants have the opportunity to receive a maximum of twenty-five (25) daily entries into the \$10,000 SKIP gift-card Grand Prize draw. Odds of winning depend on the total number of eligible entries received and the number of prizes available.
- Eligible Winner must be an existing Home Services or Mobility customer who has accumulated TELUS Reward dollars and who is an active TELUS Home Services or Mobility customer at the time of awarding the prize.
- Following the Draw Date, the Contest Sponsor or its designated representatives will make no less than two (2) attempts to contact the eligible winner by phone and/or email, during the three (3) day period (the “Contact Period”) immediately following the Draw Date. Upon notification, the eligible winner must respond by telephone and/or email to the contact provided in the notification, and the eligible winner’s response must be received by the Contest Sponsor on the required return date stipulated in such notification. If the potential winner does not respond in accordance with these Rules, he/she may be disqualified, at the sole and absolute discretion of the Contest Sponsor, in which event he/she will not receive the Prize and another potential winner may be selected from the remaining eligible Entries, in the Contest Sponsor’s sole discretion, whom the Contest Sponsor or its representatives will attempt to contact, and who must respond or will be subject to disqualification, in the same manner (adjusting timeframes, including the Contact Period, accordingly). Neither the Contest Sponsor, nor any of the other Released Parties are responsible for the failure for any reason whatsoever of the eligible winner to receive notification or for the Contest Sponsor to receive the eligible winner’s response.
- Before being declared as the confirmed winner, the Potential Winner will be required to fill out a Release and be required to answer, without assistance of any kind, whether mechanical or otherwise, a uniquely generated mathematical skill-testing question (“STQ”) administered online. If the Potential Winner has answered the STQ correctly, they must then complete and accept the Sponsor’s Declaration and Release form (the “Release Form”) in order to be declared a winner. In the event that an eligible person whose Ballot is selected does not correctly answer the mathematical STQ, fails to submit

their answer within the allotted time period, or declines to accept the Release Form, he/she will be disqualified, the Prize to which he/she may otherwise have been entitled will be forfeited by him/her and a replacement entrant will be selected at random, without any liability to the Released Parties (as defined hereafter) whatsoever. Without limiting the generality of the foregoing, the Contest Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law. No individual will be declared a winner until the Contest Sponsor officially confirms s/he as the winner in accordance with the Rules.

- By completing and returning the Release Form, and accepting a Prize, the Prize winner: (i) confirms compliance with these Rules; (ii) acknowledges that the Prize must be accepted as awarded and cannot be substituted or transferred and has no cash surrender value; (iii) releases the Contest Sponsor, its affiliated and related companies, advertising and promotional agencies, and any of its prize suppliers, the independent contest organization and their respective shareholders, directors, officers, employees and agents (the Released Parties) from and against all liability in connection with the Contest and the awarding and use or misuse of the Prize; and (iv) consents to the use of his/her name, address (city and province) and/or likeness (including photographs of the Prize winner), without further remuneration, in connection with any publicity carried out by or on behalf of the Contest Sponsor, and/or any of its prize suppliers which publicity shall be at Sponsor's sole discretion, and may be in any media whatsoever, with respect to this Contest, unless prohibited by law.

- a. The confirmed winner will be required to execute a legal agreement and release ("Release") that confirms winner's:
  - eligibility for the Contest and compliance with these Rules;

  - release of the Contest Sponsor, Prize Supplier and all of the other Released Parties from any and all liability for any loss, harm, damages, cost or expense arising out of participation in this Contest, participation in any Contest-related activity or the acceptance, use, or misuse of the Prize or any portion thereof, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy,

defamation, or portrayal in a false light, or from any and all claims of third parties arising there from; and

- grant to the Contest Sponsor and the Prize Supplier of the unrestricted right, in the Contest Sponsor's individual discretion, to produce, reproduce, publish, broadcast, communicate by telecommunication, exhibit, distribute, adapt and otherwise use or re-use the winner's name, photograph, likeness, voice and biography, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof.

- b. The executed Release must be returned within five (5) business days of the verification as a winner or the selected potential winner may, in the sole discretion of the Contest Sponsor, be disqualified and the Prize be forfeited.

The Released Parties will not be liable for: (i) any failure of any website or any platform during the Contest; (ii) any technical malfunction or other problems of any nature whatsoever, including, without limitation, those relating to the telephone network or lines, computer on-line systems, mobile devices, servers, access providers, computer equipment or software; (iii) the failure of any Entry, and/or other information to be received, captured, recorded or work properly for any reason whatsoever, including, but not limited to, technical problems or traffic congestion on the internet or at any website; (iv) any injury or damage to a participant's or any other person's computer or other device related to or resulting from participating in the Contest; (v) any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed Entries; (vi) anyone being incorrectly and/or mistakenly identified as a recipient or eligible recipient; and/or (vii) any combination of the above.

None of the Released Parties makes any representation or offers any warranty, express or implied, as to the quality or fitness of the Prize awarded in connection with the Contest. To the fullest extent permitted by applicable law, the confirmed winner understands and acknowledges that he or she may not seek reimbursement or pursue any legal or equitable remedy from either the Contest Sponsor or any of the other Released Parties should the Prize fail to be fit for its purpose or is in any way unsatisfactory. For greater certainty and the avoidance of any doubt, by accepting the Prize, the confirmed winner agrees to waive all recourse against the Contest Sponsor and all of the other Released Parties if the Prize or a component thereof does not prove satisfactory, either in whole or in part. This includes, but is not limited to, Canada's Air Passenger Protection Regulations.

## **7. INDEMNIFICATION BY ENTRANT**

By entering this Contest, each entrant releases and holds each of Contest Sponsor and prize suppliers harmless from any and all liability for any injuries, loss or damage of any kind to the entrant, Contest Sponsor and/or any of the prize suppliers or any other person or entity, including, without limitation, personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any Prize, participation in this Contest, any breach of these Rules, or in any Prize-related activity.

Each entrant agrees to fully indemnify the Contest Sponsor and the prize suppliers from any and all claims by third parties relating to the Contest, without limitation.

## **8. LIMITATION OF LIABILITY**

- a. Contest Sponsor and prize suppliers assume no responsibility or liability whatsoever for lost, late, misdirected or incomplete Entries, Requests, Donations, notifications, responses, replies to requests or any Release, or for any telephone, hardware, software or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an Entry. The Contest Sponsor and prize suppliers are not responsible for any incorrect or inaccurate information, whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Contest Sponsor and prize suppliers assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries, Requests, Donations and/or other information. The Contest Sponsor and prize suppliers are not responsible for any problems, failures or technical malfunction of any telephone network or lines on account of technical problems or otherwise. The Released Parties are not responsible for anyone being incorrectly and/or mistakenly identified as a winner or eligible winner.
- b. The Contest Sponsor and prize suppliers are not responsible for any injury or damage caused to any entrant, person or entity relating to or resulting from participating or attempting to participate in the Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive the Prize or any portion thereof. The Contest Sponsor and prize suppliers assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Contest Sponsor, such as infection by tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest.

## **9. CONDUCT**

By entering this Contest, each entrant agrees to be bound by these Rules, which will be posted at [www.telus.com/my-rewards](http://www.telus.com/my-rewards) throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Contest Sponsor, which shall be final and binding without right of appeal in all respects. The Contest Sponsor reserves the right, in its sole discretion, to disqualify any entrant found to be: (i) violating the Rules; (ii) tampering or attempting to tamper with the entry process or the operation of the Contest; and/or (iii) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

ANYONE DEEMED BY THE CONTEST SPONSOR TO BE IN VIOLATION OF THE CONTEST SPONSOR'S INTERPRETATION OF THE LETTER AND/OR SPIRIT OF THESE RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE CONTEST SPONSOR AT ANY TIME.

CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE RELATED TO THE CONTEST OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. - b. acknowledges that the Contest Sponsor may disclose his/her Personal Information to third-party agents, fulfillment partners, and service providers of any of the Contest Sponsor in connection with any of the activities listed in (a) above.

The Contest Sponsor and any third-party agents of the Contest Sponsor will use the entrant's Personal Information only for identified purposes and protect the entrant's Personal Information in a manner that is consistent with TELUS' Privacy Policy available at: [www.telus.com/privacy](http://www.telus.com/privacy). Entrants agree to TELUS' use of the entrants' personal information that may include contacting you regarding limited time offers, promotional offers and/or surveys. This section does not limit any other consent(s) that an individual may provide the Contest Sponsor or others in relation to the collection, use and/or disclosure of their Personal Information.

#### 11. **INTELLECTUAL PROPERTY**

All intellectual property, including but not limited to trademarks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, slogans, and representations are owned by the Contest Sponsors and/or the prize suppliers and/or their affiliates. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

#### 12. **GOVERNING LAW**

To the fullest extent permitted by applicable law, all issues and questions concerning the construction, validity, interpretation and enforceability of these Rules or the rights and obligations of participants, Contest Sponsor or any of the other the Released Parties in connection with the Contest shall be governed by and construed in accordance with the domestic laws of the Province of Ontario and the federal laws of Canada applicable therein,

without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. The parties hereby consent to the exclusive jurisdiction and venue of the courts located in Ontario in any action to enforce (or otherwise relating to) these Rules or relating to this Contest. For any matters which are not subject to arbitration as set forth in the Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Rules and/or the Contest, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the provincial and federal courts located in or closest to the City of Toronto in the Province of Ontario. The parties agree not to raise the defense of forum non conveniens. This Contest is subject to all applicable federal, provincial and municipal laws. SOME JURISDICTIONS (INCLUDING ONTARIO) DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES; THEREFORE, SUCH EXCLUSIONS MAY NOT APPLY TO YOU.

### 13. **LANGUAGE**

In the event of any discrepancy or inconsistency between the terms and conditions of these English Rules and disclosures or other statements contained in any Contest-related materials, including, but not limited to, the French version of these Rules (if available), television, print or online advertising and/or any instructions or interpretations of these Rules given by any representative of the Contest Sponsor, the terms and conditions of these English Rules shall prevail, govern and control to the fullest extent permitted by law.

### 14. **GENERAL**

The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.

Entrants that are customers of TELUS at the time of entry and/or at the time of prize award must have their TELUS accounts in good standing (with a current account balance that is no more than 30 days past due) in order to be eligible to win the prize.



## **SCHEDULE A - ADDITIONAL PRIZE CONDITIONS**

### **WestJet Prizes**

- 3) Airfare under the WestJet Vacation Package is limited and subject to availability of promotional space, eligible fare options, and flight schedule. Not all flights have promotional space. The WestJet Vacation Package is not valid for redemptions on flights operated by codeshare partners, charters, or any interline flights.
- 4) Winner and winner's guest must be under the same bookings under the Vacation Prize Package. No substitutions or name changes for winner or winner's guest will be permitted once bookings are confirmed.
- 5) The WestJet Vacation Package is subject to certain blackout dates, including statutory holidays and peak travel dates, as determined by WestJet at its sole discretion.
