Ibstock sets ambitious new carbon reduction targets

Ibstock, a leading UK manufacturer of clay bricks and concrete products, is pleased to announce ambitious new carbon reduction commitments, including a target for the business to be net zero carbon by 2040.

Having substantially achieved our existing goal of a 15% reduction in CO2 per tonne of production, the Group has established new, more stretching targets to achieve a 40% reduction by 2030, and a commitment to become net carbon zero by 2040. This ambitious new net zero commitment will cover scope 1 & 2 emissions and will include investment in more efficient production processes and in high quality environmental projects to offset residual carbon. A strategy to reduce Ibstock's indirect Scope 3 carbon emissions, which contribute less than 40% of the business impact, will be developed in 2022.

These new targets build on the Group's existing sustainability roadmap commitments, creating a framework of targets and critical milestones at the centre of a new 2030 sustainability strategy. Full details of the new sustainability strategy and net zero journey will be published in March 2022, as part of the Group's 2021 results announcement.

Joe Hudson, Chief Executive Officer, commented: "These new carbon commitments, including our pledge to be net zero by 2040, represent a bold step on the Company's journey to address climate change and move the business into the low carbon economy. I am proud of our colleagues across the business who are driving forward our sustainability agenda and securing its place at the core of our purpose as a business and I look forward to presenting our ambitions and targets in March 2022."

Notes:

Scope 1 emissions – direct Green House Gas (GHG) emissions from operations that are owned or controlled by lbstock. Scope 2 emissions – indirect emissions from electricity lbstock buys from the grid for use at our facilities (factories and offices). Scope 3 - other indirect emissions which result from lbstock PLC activities such as procurement and haulage.
