(short "MANGOPAY"), is a public limited liability company incorporated in Luxembourg (B173459), holds an E-Money Institution (EMI) license granted by the Commission de Surveillance du Secteur Financier (CSSF) Luxembourg. (No.: W00000005) As per European passporting, the license covers all 31 countries of the EEA.

Product Profile

MANGOPAY's product gives their clients the possibility to offer a digital escrow service and payment services to their customers, as well as Know-Your-Customer / Anti-Money-Laundering processes as required per EU-wide regulations.

MANGOPAY currently services over 2500 clients in 26 European countries, targeting customers in 15 currencies worldwide using 16 international and local means of payment.

Funds processed via MANGOPAY are held in escrow on 100% guaranteed ring-fenced accounts that keep all funds/assets separated from the balance sheets of MANGOPAY itself as well as their clients to ensure 100% protection against any sort of liquidation.

Company Context

MANGOPAY (as part of "Leetchi Group") is a subsidiary of the French Crédit Mutuel Arkéa (Principal office: 1, rue Louis Lichou, 29480 Le Relecq-Kerhuon, France as per 06.07.2020), a banking group with over 10 000 employees, equity exceeding 7 billion EUR (2019) as well as total registered assets of over 157 billion EUR (also 2019).
