INFORMATION

on personal data processing (pursuant to EU Regulation No. 2016/679)

Premise

Pursuant to art. 13 of EU Regulation No. 2016/679 ("GDPR") concerning the protection of individuals with regard to personal data processing, as well as to the free circulation of such data, and which repeals Directive No. 95/46/EC, the University of Milan informs the subjects participating in the initiative, promoted by the University Veterinary Hospital of Lodi, for the administration of online surveys for research purposes.

1. Data Controller and Data Protection Officer (DPO)

The data controller is Università degli Studi di Milano, in the person of the pro tempore Rector: 7, Festa del Perdono street, 20122 Milan, e-mail: infoprivacy@unimi.it.

Pursuant to art. 37 and following of EU Regulation No. 2016/679, the University has appointed the Data Protection Officer (DPO) in the person of lawyer Pierluigi Perri, at *Cesare Beccaria* Department: 3, Festa del Perdono street, 20122 Milan, e-mail: dpo@unimi.it.

2. Processing purpose and legal basis

Personal data - such as name, surname, email address and telephone number-, provided directly by the interested parties by completing the online survey, will be processed within the University institutional purposes, for the exclusive purposes of scientific research.

The processing legal basis consists in the consent of the interested party.

The provision of data is a necessary requirement for completing the survey.

3. Treatment methods

Data collection takes place in compliance with the principles of relevance, completeness and non-excess in relation to the purposes for which they are processed.

The personal data provided are processed in compliance with the principles of lawfulness, correctness and transparency, under the provisions laid down in article 5 of the GDPR, also with the aid of informatic and telematic tools designed to store and manage the data, and in any case in such a way as to guarantee their security and protect the maximum confidentiality of the interested party.

The data can be processed anonymously for carrying out statistical activities.

4. Categories of subjects authorized to process data and to whom the data may be communicated

The personal data of the interested parties will be processed, in compliance with the current relevant legislation, by University employees and collaborators appointed as Authorized for processing.

The data will not be disclosed to third parties.

In any case, this is without prejudice to the communication or dissemination, in accordance with the law in force, of data requested by the Public Security Authority, by the Judicial Authority or by other public entities for the purposes of defense, State security and investigation of crimes, as well as to the communication to the Judicial Authority in compliance with legal obligations, when there is a hypothesis of crime. Apart from the aforementioned cases, personal data are not communicated or disclosed to third parties in any ways and for any reasons.

No personal data will be transferred to third countries or international organizations.

5. Data retention

The personal data collected will be stored until the end of the scientific research.

6. Rights of the interested party

The interested party can lodge a complaint to a supervisory authority and exercise, pursuant to articles from 15 to 22 of the GDPR, the right to:

- ask the data controller to access personal data which concern them, to correct or cancel these data, to limit their processing;

- oppose the processing;

- ask for data portability,
