* Telepass S.p.A. informs you that, if you qualify as a "consumer" for the purpose of Directive 2011/83/EU and the Italian Legislative Decree no. 206/2005 ("Consumer Code"), you have the right to withdraw from the Go by Telepass Online Contract concluded through the available online procedures, pursuant to Article 9 of the aforementioned Directive and Article 52 of the Consumer Code, without stating the reasons and without penalties, within 14 days from the date of conclusion of the Contract, in accordance with the Rules and Conditions of the Contract that you have entered into and without incurring costs other than those provided for in Article 56, paragraph 2 and Article 57 of the Consumer Code, without prejudice to (i) what may be due for tolls and other fees relating to the services used, through the European Telepass Device that is at your disposal, until Telepass receives the European Telepass Device, and (ii) your payment of an amount equal to a monthly portion of the service fee due under the said Contract.

Before the expiration of the aforementioned period of fourteen days, you may notify Telepass S.p.A. of your withdrawal: (a) by sending a written communication (also using this form) by registered letter with return receipt to the following address: TELEPASS S.p.A. - Customer Care – Casella Postale 2310 succursale 39 - 50123 FIRENZE, taking care to specify the number of the Contract and your Name and Surname, and to attach a copy of an identity document; in this case, if you have already received the European Telepass Device, you will be required to return it to a Punto Blu (Blue Point) or motorway Concessionaire Service Center or by sending it by registered mail to Telepass S.p.A. at the above address; (b) by going directly to a Punto Blu (Blue Point) or motorway Concessionaire Service Center and returning any European Telepass Equipment received.
