

PRIVACY NOTICE CONSULTANT**CEVT****1. INTRODUCTION**

China Euro Vehicle Technology AB, organization number 556922-7639, Theres Svenssons gata 7, 417 55 Göteborg, Västra Götalands län ("CEVT") collects and processes the information that the organization will need in order to perform along with the companies short respectively long-term goals ("**Personal data**"). This privacy notice ("**Privacy Notice**") sets out which Personal data that we collect and for which purposes it is processed, as well as your rights connected to the processing of your Personal data.

Throughout this Privacy Notice the term "processing" is used which covers all activities involving your Personal data, including collecting, handling, storing, sharing, accessing, using, transferring and disposing of information.

Explanation to the legal grounds listed above

Legal obligation. Example, CEVT may be obliged by law to report transactions to a tax authority requiring CEVT to process your Personal data.

Contractual obligation. Example, CEVT may be required to process your Personal data to fulfill the terms and agreements of an order or a service contract signed by you or your company.

Legitimate interests. Example, CEVT’s legitimate interests include the interest to manage its daily operations according to lawful and fair business practices including managing its relationships with its consultant in order to perform contract(s) to which you or your company is a party and/or to take steps necessary prior to entering into a contract with you or your company.

Consent. Example, in exceptional cases CEVT may ask separately for your consent to process your Personal data for certain purposes. If consent is collected, you are always entitled to withdraw your consent, which will however not affect the lawfulness of the processing based on consent before its withdrawal.

Sensitive Personal data entails Personal data from which we can determine or infer an individual's racial or ethnic origin, political opinions, religious beliefs or other beliefs of a similar nature, membership of a trade union, physical or mental health or condition, sexual life, or judicial data.

3. DISCLOSURE AND TRANSFER OF PERSONAL DATA

CEVT may disclose Personal Data processed for the purposes set forth in section 2 above to other companies within the Geely Group or outside of the Geely Group. Such recipients may be located in countries inside or outside the EU/EEA. To ensure adequate protection of your Personal Data when transferred outside the EU/EEA, both CEVT and the receiving companies have entered into personal data transfer agreements based on the Standard Contractual Clauses of the European Union or other adequate safeguards are applied.

The following is a list of the countries located outside EU/EEA, to which your Personal Data may be transferred:

- China
- Singapore
- United States of America
- India
- Malaysia

4. REVOCATION OF CONSENT

You may, at any time, revoke consents that you have given to CEVT pertaining to any such processing of Personal data which is based on your consent.

You may revoke your consent by contacting CEVT on the contact details set forth below and state for which of the abovementioned purposes you wish to revoke your consent. CEVT will cease to process your Personal data relating to the purposes for which your consent has been revoked and you will receive verification by CEVT that your Personal data no longer will be processed for that purpose. You acknowledge that you, upon revocation of your consent, may in certain situations be entitled to require erasure of your Personal data related to the purpose for which you have revoked your consent.

5. YOUR RIGHTS

You have the right to exercise your rights as a Data subject. Such request should be lodged to the data protection officer at CEVT (see contact details below).

5.1.1. Right to access

You are entitled to obtain a confirmation from CEVT as to whether your Personal data are being processed by CEVT and, if so, access to the Personal data and the following information:

- i) the purposes of the processing;
- ii) the categories of Personal data processed;
- iii) the recipients of Personal data (in particular in countries outside EU/EEA);
- iv) the envisaged time during which the Personal data will be processed;
- v) information about the rights stated herein;
- vi) information about the source from which the Personal data are collected; and
- vii) the existence of automated decision-making, including profiling.

Moreover, you are upon your request entitled to receive a copy of your Personal data in a commonly used electronic format.

5.1.2. Right of rectification

CEVT will take steps in accordance with the applicable legislation to keep your Personal data accurate, complete and up-to-date. If you identify that any Personal data related to you is inadequate, incomplete or incorrect, you are entitled to have the Personal data corrected.

5.1.3. Right to objection

If the processing of your Personal data is based on a balancing of interests and you deem that your integrity interest overrides CEVT's legitimate interest to process your Personal data, you may, on grounds related to your particular situation, object to the processing by contacting CEVT on the contact details in section 6 below, in which case CEVT must have a compelling reason in order to continue to process the Personal data for the relevant purpose.

5.1.4. *Right to erasure*

Under certain circumstances, such as when you have revoked you previously given consent and there is no other legal ground available for CEVT to process your Personal data, you may request to have your Personal data erased.

5.1.5. *Right to restriction*

You are under certain circumstances entitled to restrict the processing of your Personal data to only comprise storage of the Personal data, e.g. during the time when CEVT assesses whether you are entitled to have Personal data erased in accordance with section 5.1.4 above.

5.1.6. *Right to data portability*

When Personal data is processed on the basis of your consent or on the basis that the processing is necessary in order to perform under a contract with you, and provided that the Personal data have been provided by you, you are entitled to receive a copy of your Personal data in a common machine-readable format.

5.2. **COMPLAINTS TO THE SUPERVISORY AUTHORITY**

You are welcome to contact us with any enquiries and complaints that you may have regarding the processing of your Personal data. However, you also have the right to lodge complaints pertaining to the processing of your Personal data to the Swedish Data Protection Authority (*Sw. Datainspektionen*).
