Allocation criteria for student housing connected with the Student Welfare Organisation in Southeastern Norway (SSN)

Regulations for allocating leases for the Student Welfare Organisation's housing (changes are valid from 1.1.2023).

§1. Scope of application

1.1 These regulations apply to the allocation of student housing operated by the Student Welfare Organisation in Southeastern Norway (SSN).

§2. Who can apply?

- 2.1 Students affiliated with the University of Southeastern Norway (USN), The Technical College in Viken (Tinius Olsen), The Technical College in Vestfold and Telemark, Folkeuniversitetet Sør-Øst or the Norwegian Police University College in Stavern, whose studies are progressing normally/are their main occupation and pays tuition fee to SSN.
- 2.2 Students registered at other schools/universities but following a course at a school affiliated with SSN, if they have paid the tuition fee to SSN.
- 2.3 Persons who have not yet started their studies, but who plan to study during the lease period, if they can prove student status at the start of the lease period.
- 2.4 Empty accommodations can be allocated to persons other than those who are entitled in accordance with these regulations. Such allocations are valid until July 31st and are given no priority during new allocations.
- 2.5 Students and others that apply for housing with SSN must be aged 18 years or older.

§3. Obligation of applicants and tenants to provide information

- 3.1 The applicant must ensure that all information relevant to an application assessment are correct and complete.
- 3.2 SSN has the right to verify the information given in the application. Incorrect and/or incomplete information may lead to the revocation of any contract. SSN has the right to verify that the tenant is still eligible for student housing at any time.

§4. Order of priority in the allocation of housing

- 4.1 Existing tenants applying to renew a lease/accepting an extension.
- 4.2 International students according to the current agreement between SSN and USN.
- 4.3 Existing tenants applying to be allocated different housing ("internal relocation"), except for such applications received during the semester start months (January and August).
- 4.4 International students who by agreement with institutions affiliated with USN have reserved housing. The lease period for these starts either on August 1st or January 1st. The reservation deadline for institutions and the application deadline are June 1st and November 1st.

- 4.5 Other eligible applicants are prioritized by the date of application. Applicants who are not allocated housing are placed on a waiting list.
- 4.6 When allocating family housing, student couples and single parents with the daily care of children are prioritized.
- 4.7 Tenants who move out of SSN-housing after April 15th, and then apply for a new lease for the autumn semester of the same year, will not be prioritized on the waiting list.
- 4.8 Applications that are not actively extended in our systems within two months will be automatically deleted from the waiting list.

§5. Exception criteria

5.1 Applicants who for social/medical/other reasons should get housing can be prioritized. There must be documentation.

§6. Duration of the tenancy agreement

- 6.1 The total length of tenancy allowed is standardized to the completion of studies and with a maximum length of five years. An extension to the lease period may be granted in the event of delays during their studies due to illness, childbirth, military service, etc. An application and documentation are required.
- 6.2 SSN rent out dorms and flats on fixed-term leases from August 1st to July 31st, with the right to renew the contract if the aforementioned criteria can still be met, and the housing will continue to be rented out as student housing by SSN.
- 6.3 SSN operates with a notice period of three months from the 1st of the following month. Special rules apply for those allocated housing prior to being admitted to study and then not being given a place. Tenancy agreements signed from 1 August, can then be cancelled by <u>sending written notice</u> to SSN's housing department or by terminating the contract on <u>My page</u> by 31 July.
- 6.4 All housing is allocated continuously from the time it is available for rent.

§7. Allocation, complaints and appeals

- 7.1 SSN allocates housing in accordance with the above-mentioned allocation criteria.
- 7.2 Anyone who processes applications in accordance with these regulations has an obligation of confidentiality to not disclose private information that they become aware of when dealing with an application.
- 7.3 A complaint/appeal regarding allocation must be made in writing to the housing division at SSN within 14 days of the allocation. If the housing division of the Student Welfare Organisation does not find grounds to change its decision, the case will be submitted to the SSN board, which will make the final decision.

§8. Re-evaluation of the regulations

8.1 These regulations are submitted to the board for re-evaluation when the SSN administration or others consider it appropriate.
