



## PCGS 40<sup>th</sup> Anniversary Blind Packs Sweepstakes

### Official Rules

- **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**
- **VOID WHERE PROHIBITED BY LAW.**
- **AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY / PRIZE ACCEPTANCE AGREEMENT MAY BE REQUIRED.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, ENTRANTS AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES ENTITIES (DEFINED BELOW) FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

**1. Eligibility.** The PCGS 40<sup>th</sup> Anniversary Blind Packs Sweepstakes (the “**Sweepstakes**”) is open only to individuals who are, prior to time/date of entry: (i) members of the PCGS Collectors Club; (ii) legal residents and physically located in one (1) of the fifty (50) United States or the District of Columbia; and (iii) at least eighteen (18) years of age or older. Employees, officers and directors of Professional Coin Grading Service, a division of Collectors Universe, Inc. (“**Sponsor**” or “**PCGS**”), its parent company, and each of their respective affiliates, subsidiaries, advertising and promotion agencies, distributors, and other prize suppliers (collectively with Sponsor, the “**Sweepstakes Entities**”), and each of such employees’, officers’ and directors’ immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to enter the Sweepstakes or win a prize. For purposes of this Sweepstakes, “immediate family members” are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and “those living in the same household” shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Void where prohibited by law. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these “**Official Rules**” and the decisions of Sponsor, including the interpretation of these Official Rules and its exercise of discretion, which will be final and binding in all respects.

**2. Entry Period.** The Sweepstakes begins on or about 12:00 a.m. Pacific Time (“**PT**”) on Wednesday, April 1, 2026 and all entries must be received by the Sponsor on or before 11:59 p.m. PT on Tuesday, June 30, 2026 (the “**Entry Period**”).

**3. How to Enter.** There are two (2) methods of entry for this Sweepstakes, and you may enter as follows:

- Purchase Method of Entry.** To enter the Sweepstakes, during the Entry Period, visit the website <https://www.pcgs.com/submissions>, and follow the steps described therein to submit an order form for at least one (1) coin to be graded by PCGS. Each online entrant will need a PCGS account (a “**PCGS Account**”) to enter the Sweepstakes through this online method of entry. If you don't already have a PCGS Account, visit <https://app.collectors.com/signin> to create a PCGS Account. Creating a PCGS Account is free. By submitting your information and creating a PCGS Account, you will be required to agree to the PCGS Grading Terms and Conditions (available at <https://www.pcgs.com/termsandconditions/grading>) and acknowledge the PCGS privacy notice (available at <https://app.collectors.com/privacypolicy>). If you do not agree to PCGS Grading Terms and Conditions and acknowledge the privacy notice, you cannot create a PCGS Account and enter the Sweepstakes. Once you have created a PCGS Account and are logged in, entrants must then complete the following steps to gain an entry into this Sweepstakes: (a) complete the steps to submit an order form for one (1) or more coins or banknotes to be graded by PCGS as described at <https://www.pcgs.com/submissions>; and (b) send your coins to PCGS as instructed during checkout and ensure that the postmark of your coin and/or banknote package is on or before the Entry Period end date above. For clarification, there are additional ways to submit coins to be graded by PCGS including via show submissions, mail-in, online and bulk deals and all submission methods are a valid way to receive a Sweepstakes entry. The cost for having your coin(s) and/or banknote(s) graded will vary and will be disclosed at your time of purchase. **If PCGS does not receive your coin(s) and/or banknote(s) for grading by July 6, 2026, you will not be entered into this Sweepstakes.**
- Alternate Mail-In Method of Entry.** To enter the Sweepstakes without submitting your coins or banknotes for grading to PCGS, during the Entry Period, you may legibly hand print on a 3” x 5” card, your full name, complete valid postal address, date of birth, telephone number, Collectors ID and valid email address, and mail it in envelope with the proper postage affixed, to: PCGS 40<sup>th</sup> Anniversary Blind Packs Sweepstakes Mail-In Entry, Attn: PCGS Blind Packs, 1610 E. **RECOMMEND YOU SEND THE 3x5 CARD IN AN ENVELOPE.** A mail-in entry will earn entrant one (1) entry in the drawing and must be submitted to Sponsor at the address above in a separate envelope (or item of mail). A mail-in entry must be postmarked on or before June 30, 2026 and received by Sponsor no later than Monday, July 6, 2026 to be eligible for the Sweepstakes. If you don't already have a Collectors ID, visit <https://app.collectors.com/signin> to create a PCGS Account and receive your Collectors ID. Creating a PCGS Account and receiving a Collectors ID are free. By submitting your information and creating a PCGS Account, you will be required to agree to the PCGS terms of service and privacy notice. If you do not agree to PCGS's terms of service and privacy notice, you cannot create a PCGS Account or receive a Collectors ID and cannot enter the Sweepstakes through this mail-in method of entry.

Limit of one (1) entry per person during the Entry Period (regardless of method) will be accepted. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. All materials submitted become the physical property of Sponsor and will not be returned. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the registered account holder of the email address associated with the entry or the domain associated with the submitted address provided that person is eligible. Winners may be required to show proof of being the registered account holder. "Registered account holder" is defined as the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. Sponsor's designated database clock will be the official timekeeper for this Sweepstakes. Those who do not follow all of the instructions, provide the required information in their entry form or abide by these Official Rules or other instructions of Sponsor may be disqualified. The Sweepstakes Entities may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes does not constitute entry into any other.

**4. Selection of Winners and Prize Claiming.** There will be a total of one hundred (100) winners selected in this Sweepstakes. Each potential winner will be selected through a random drawing on or about July 16, 2026 from all eligible entries received during the Entry Period in accordance with these Official Rules. Sponsor will have complete discretion over interpretation of the Official Rules, of administration of the Sweepstakes and of selection of the winners. Decisions of the Sponsor as to the selection of winners will be final. Each potential winner will be notified via blind pack by mail if they have been selected as a winner in this Sweepstakes. If an individual is a winner, their blind pack envelope will contain a code that the potential winner can redeem. Instructions on redemption will be provided via a website page with detailed step-by-steps as well as on the prize notification letters. The Sweepstakes Entities are not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email, placing of a phone call, one (1) day after sending via a delivery service or two (2) days after mailing. A potential prize winner who provides a P.O. Box may be required to provide an alternative address and this may cause a delay in notification and acceptance so use of a P.O. Box is discouraged. The Sweepstakes Entities are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email account to receive email messages.

Each potential winner may be required to submit an affidavit of eligibility / release of liability / prize acceptance agreement (including a special tax consent document) (collectively, the "Affidavit") and return the Affidavit within the time period specified at notification before being eligible to receive his or her prize. If a potential prize winner fails or refuses to sign and return such Affidavit within the time period required by Sponsor or if the prize or prize notification is returned as rejected, faulty, unclaimed or returned as undeliverable to such potential prize winner, such potential prize winner may be disqualified and an alternate may be selected. Non-compliance shall result in disqualification and award of the prize to an alternate winner. Parents or legal guardians of any prize winner under the age of majority in the prize winner's state of residence (which is eighteen (18) in most states but is nineteen (19) in Alabama and Nebraska and twenty-one (21) in Mississippi) may be required to also sign the Affidavit in order for the prize winner to be qualified to receive the prize winner's prize. If a potential prize winner is found to be ineligible, or if the prize winner has not complied with these Official Rules, or if a potential prize winner cannot attend or participate in any portion of the prize, or declines a prize for any reason prior to award, such potential winner may be disqualified and an alternate potential winner may be selected. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners or remaining winners, as the case may be, of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. The Sweepstakes Entities are not



responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected or unsuccessful efforts to notify the potential winners, or if potential winner is a minor, for late, lost, misdirected or unsuccessful efforts of a potential winner to provide signed parental or guardian consent.

**5. Odds.** Odds of winning will depend upon the total number of eligible entries received during the Entry Period.

**6. Prizes and Value.** Each winner will receive a prize that is randomly assigned to the winner by Sponsor, consisting of one (1) of the following prizes listed below, as determined by Sponsor in its sole and absolute discretion:

- (i) **Chase Coin: [three (3) available]**
  - a. **One (1) 2026 MS 70 Silver Eagle**, with an ARV of \$100.00
  - b. **One (1) 2026 MS 70 Silver Eagle**, with an ARV of \$100.00
  - c. **One (1) ¼ oz 2026 MS 70 Gold Eagle**, with an ARV of \$1,400
- (ii) **Front-of-the-line passes: [thirty-three (33) available]** – Front-of-the-line passes may only be redeemed at eligible PCGS onsite grading shows to allow recipient a front of line pass to skip the line and proceed directly to a PCGS customer care associate to drop off their coin or banknote for grading. Upon sending the redemption code marked on their prize notification letter to customer care, Sponsor will mail winner a physical front of line pass. Front-of-the-line pass will expire on **December 30, 2026**. Passes will be subject to terms and conditions set forth on the pass themselves and any terms and conditions communicated by Sponsor at time of prize award. There is no retail value for a front of line pass and passes are non-transferable.
- (iii) **10% Show Discount: [thirty-two (32) available]** – 10% show discount coupon may only be redeemed for 10% off a purchase of a regular coin grading service at a PCGS onsite grading show. Prize will be awarded in a physical coupon format and may only be redeemed in person at the PCGS booth at an eligible trade show. There is a five (5) coin maximum submission limit when using the 10% show discount coupon and can only be used for the Show Economy service level. Coupon is subject to an expiration date set forth on the coupon. Coupons will be subject to terms and conditions set forth on the coupon and any terms and conditions communicated by Sponsor at time of 10% show discount coupon award. There is no retail value for a 10% show discount coupon and coupons are non-transferable.
- (iv) **\$40 voucher: [thirty-two (32) available]** – \$ 40 voucher coupon may only be redeemed for grading services for 1 coin at the Regular service level. Prize will be awarded in a physical coupon format and may only be redeemed through PCGS customer care. Coupon is subject to an expiration date set forth on the coupon. Coupons will be subject to terms and conditions set forth on the coupon and any terms and conditions communicated by Sponsor at time of \$40 voucher coupon award. The ARV of each \$40 voucher coupon is \$40.00.

Except where required by law, each prize is non-transferable, with no cash redemptions, equivalents or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and prize provider's rules and restrictions, and in the event that Sponsor is unable to provide a winner with the winner's prize, Sponsor may elect to provide a winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. All prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Prize winners will be solely responsible for all federal, state, and/or local taxes, and for any other fees or costs associated with the prizes they receive, regardless of whether they, in whole or in part, are used. The ARV of the prizes is based on available information provided to Sponsor and the value of any prize awarded to a winner may be reported for tax purposes as required by law. The winners may be required to provide Sponsor with a valid social security number before the prize will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of winners, or if a minor in the jurisdiction in which the winner resides, in the name of the winner's parent or legal guardian, for the actual value of the prize received. Unclaimed prizes will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Entities are not responsible for and will not replace any lost, mutilated or stolen prizes or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited and the Sweepstakes Entities will have no further obligation with respect to that prize or portion of the prize. No more than the stated prizes will be awarded. The total ARV of all of the prizes awarded in the Sweepstakes is \$2,880. The Sweepstakes Entities are not responsible for and winner will not receive the difference, in any, between the actual value of the prizes at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Each prize will only be mailed to the verified winner's physical mailing address (no P.O. Boxes) in one (1) of the fifty (50) United States or the



District of Columbia, except in Sponsor's sole and absolute discretion. Please allow at least thirty (30) days for delivery of the prize after Sponsor's receipt of the Affidavit and/or other prize confirmation documents. Limit of one (1) prize per person.

**7. Publicity Release.** Subject to applicable law, each winner irrevocably grants to the Sweepstakes Entities, and each of their licensees, and its and their successors, assigns and sub-licensees, the right and permission to use the winner's name, voice, likeness and/or biographical material for advertising, promotional and/or publicity purposes in connection with the Sweepstakes, in all forms of media and by all manners (now and hereafter known), and on and in connection with related products, services, advertising and promotional materials (now known or hereafter developed), worldwide, in perpetuity, without any obligation, notice or consideration, except for the awarding of the prizes to the winners.

**8. Tampering with Sweepstakes.** The Sweepstakes Entities are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Persons found tampering with or abusing any aspect of this Sweepstakes, or whom Sponsor believes to be causing malfunction, error, disruption or damage may be disqualified. Additionally, any attempt to cheat the Sweepstakes, as determined at the sole and absolute discretion of Sponsor, may result in immediate disqualification of the entrant, as well as other possible consequences, including disqualification from any and all existing and future sweepstakes. ANY ATTEMPT BY A PERSON TO DAMAGE ANY WEBSITE (INCLUDING THE SWEEPSTAKES WEBSITE) OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK ALL LEGAL AND EQUITABLE REMEDIES FROM AND AGAINST ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. Sponsor reserves the right, at its sole and absolute discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in violation of these Official Rules, or to be acting in an unsportsmanlike, obscene, immoral or disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person.

**9. Suspension / Modification / Termination.** In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should a Force Majeure event or occurrence corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.

**10. Waivers, Disclaimers and Releases.** By participating in the Sweepstakes, entrant agrees to release, discharge, indemnify, defend and hold harmless the Sweepstakes Entities and each of their respective directors, officers, employees, agents, successors and assigns ("Released Parties") from and against any and all claims, liability, costs (including attorneys' fees), losses, damages, fines or injuries (up to and including bodily injury and death) of any kind arising out of or related to: (i) entrants' participation in the Sweepstakes (including travel to/from any Sweepstakes activity); (ii) any acceptance, possession, misuse or use of any prize (including, without limitation, losses, damages or injuries to entrant's or any other person's equipment or other property, or to their persons, including those arising from any travel to/from any prize event or activity); (iii) the Released Parties' actual or alleged violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; and (iv) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize. Without limiting the generality of the foregoing, entrants agree that the Released Parties: (a) have neither made nor will be in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, in connection with the Sweepstakes and/or with respect to prizes, including, without limitation, to any prize's quality or fitness for a particular purpose; (b) maintain no control over the personnel, equipment or operation of any air, water or surface carrier, ship line, bus or limousine company, transportation company, hotel, manufacturer or other person or entity furnishing services, products or accommodations (collectively, "Suppliers") as a part of the prizes provided in connection with the Sweepstakes; and (c) will not be responsible or liable for any injury, damage, loss, expense, accident, delay, inconvenience or other irregularity that may be caused or contributed to: (i) by the wrongful, negligent or unauthorized act or omission on the part of the Suppliers or any of their agents, servants, employees or independent contractors, (ii) by any defect in or failure of any vehicle, equipment, instrumentality, service or product that is owned, operated, furnished or otherwise used by any of those Suppliers, (iii) by the wrongful, negligent or unauthorized act or omission on the part of any other person or entity not an employee of the Released Parties, and (iv) by any cause, condition or event whatsoever beyond the control of the Released Parties. Entrants agree and that the Released Parties shall have no responsibility or liability for discontinued



prizes; human error; incorrect or inaccurate transcription of registration and/or account information; any technical malfunctions of the telephone network, computer online system, computer dating mechanism, computer equipment, software, or Internet service provider utilized by Sponsor; interruption or inability to access any Survey website or Sponsor or affiliated entities' respective websites, or any online service via the Internet due to hardware or software compatibility problems; any damage to participant's (or any third person's) computer and/or its contents related to or resulting from any part of the Sweepstakes; any lost/delayed data transmissions, omissions, interruptions, viruses, bugs, defects; and/or any other errors or malfunctions, even if caused by the negligence of the Released Parties. Each entrant further agrees to indemnify, defend and hold harmless the Released Parties from and against any and all liability resulting or arising from the Sweepstakes and to release all rights to bring any claim, action or proceeding against Released Parties and hereby acknowledge that the Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to a prize, including express warranties provided exclusively by a Supplier that may be sent along with a prize.

**11. Entry Information and Sweepstakes Communications.** As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver the entrant's name, address and other information to third parties for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules. Any information entrant provides to Sponsor may be used to communicate with entrant in relation to this Sweepstakes or on a Sweepstakes winners' list. Any information submitted by or collected from any individual by Sponsor is subject to Sponsor's Privacy Policy available at: <https://www.collectors.com/privacy>.

**12. Governing Law / Limitation of Liability.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Delaware, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00) (USD), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00) (USD), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

**13. Dispute Resolution.** You agree that any claim or dispute that has arisen or may arise relating in any way to or arising out of the Sweepstakes or these Official Rules will be resolved in accordance with the dispute resolution and arbitration provisions set forth in the "DISPUTE RESOLUTION AND ARBITRATION" Section of the Collectors User Agreement (available at <https://app.collectors.com/collectorsuseragreement>).
